## Interim support for exploited migrants in Auckland

### **Purpose**

To seek your agreement on an interim package of support for the cohort of exploited migrants who had been granted Accredited Employer Work Visas, who require immediate support from Immigration New Zealand.

A Cabinet paper proposing a broader package of support will be provided to Cabinet for its consideration on Monday, 18 September.

The Ministry of Business, Innovation and Employment recommends that you:

#### **Background**

- 1. On Sunday 13 August 2023 Immigration New Zealand (INZ) became aware of a number of Indian nationals residing at a Papakura property, who had arrived in New Zealand on Accredited Employer Work Visas (AEWV) and the promised employment had not materialised<sup>1</sup>.
- 2. These migrants told INZ that they had paid large sums of money to obtain the visa and the job in New Zealand.
- 3. An MBIE investigation was launched and almost immediately 5 other properties in Auckland, housing Indian and Bangladeshi migrants with similar stories were discovered.
- 4. As of Thursday, 17 August 144 migrants have been identified as an initial cohort of migrants who are in need of immediate support.
- 5. This identified cohort of migrants is currently living in substandard housing and are at risk of eviction, and require accommodation to be provided by Friday, 8 September.
- 6. On Monday, 4 September the Minister of Immigration, took an oral item to Cabinet expressing concern regarding the cohort of identified migrants, and the need for further work to be undertaken to identify a broader package of support for the holders of a Migration Exploitation Protection Visa (MEPV).
- 7. On Tuesday, 5 September the Minister of Immigration wrote to MBIE with Ministerial instructions for MBIE to provide advice for Cabinet on a systematic approach to support those claiming migrant exploitation. This advice will be provided for Cabinet's consideration on Monday, 18 September.
- 8. However, in the interim MBIE will offer accommodation and welfare support to the migrants who will require housing from Friday, 8 September. The cost of this interim support package will be met from INZ's baseline funding through reprioritising Crown funding from other initiatives.
- 9. Treasury have advised that, as this is a new initiative, the provision of this support requires a decision from Joint Ministers, under the Joint Minister's delegation from Cabinet who have power to act in the over the General Election and Government Formation period, to authorise this.
- 10. Joint Ministers' approval is urgently required so that INZ can contract with an accommodation provider.

## Scope of the interim package of support

- 11. MBIE proposes an interim package of support be provided to this cohort of identified migrants. This package is expected to cost approximately \$200,000, and includes:
  - a. Approximately \$50 per person, per day, for accommodation in a motel (paid directly to the accommodation provider); and
  - Approximately \$220 per person, per week of living cost support payments.
- 12. While this package of support will be available to all members of the identified cohort of migrants, INZ is currently unclear as to the exact numbers of migrants who will take up the offer. There is a risk that more migrants may be identified as being in a similar position and

may require this assistance as well. A package of \$200,000 will enable INZ to provide support to the identified cohort of 144 migrants until Monday, 18 September, and up to 100 additional migrants if required.

#### Accommodation cost

- 13. INZ has existing relationships with accommodation providers, and are currently negotiating to contract the provision of accommodation services.
- 14. The indicative cost of approximately \$50 per person, per day. This is comparable to similar support available to asylum claimants who cannot work.

#### Living cost support payments

- 15. INZ will organise interim living cost support payments for the cohort of identified migrants of approximately \$220 per person, per week. This is approximately \$32 per person, per day, to cover food, transport, and other essential items.
- 16. This level of living cost support is also in line with existing support available to asylum claimants who cannot work.

#### **Next steps**

17. A Cabinet paper is being prepared for consideration on Monday, 18 September which will outline a broader package of support for MEPV holders.
