Changes have been made to the Cabinet paper

Some arise from your discussions with Minister McCully

 Paragraphs 8 and 11, which outline the decision-making process for quota refugees, have been added. S 6(a)

These

paragraphs include details of security measures undertaken. Paragraphs 12 – 16 have been reordered.

Additions have been made to the paper to respond to Treasury's issues

- Paragraphs 24 and 25 have been amended to present the proposed building of the new accommodation blocks and classrooms more clearly as a variation to the existing rebuild of the Mangere Refugee Resettlement Centre.
- Recommendation 13 therefore now asks Cabinet to agree in principle additional funding for the building of a new block of three classrooms, subject to final approval from Investment Ministers in June 2016.
- 4. We do not believe there are any more issues to resolve with Treasury but this has not been confirmed.
