

Freedom Camping infringement offences and penalties

June 2023

- Infringement offences from the Freedom Camping Act (FCA) prior to the Self Contained-Motor Vehicles Legislation Act remain in place for local authority and Department of Conservation land.
- There are new infringement offences for breaching rules associated with freedom camping in a self-contained vehicle.
- There are new infringement offences associated with freedom camping on LINZ land.
- Regulations setting out infringement offences have been made. From 13 July 2023, a person who commits an infringement offence is liable to the penalties set out in the table below.
- The maximum fine level relates to the maximum penalty the Court can impose on a person found guilty of committing an infringement offence.

*Making preparations to freedom camp in a non-self- contained vehicle in breach of the national rule ⁷	\$400	\$1,200	
Making preparations to freedom camp in a self- contained vehicle with more people than the vehicle is certified for ⁸	\$400	\$1,200	
Failing or refusing to leave a local authority area when required to do so by an enforcement officer ⁹	\$600	\$1,800

Infringement offences	Infringement fee	Maximum fine	
Freedom camping in breach of a prohibition or restriction specified in a notice ¹⁰	\$400	\$1,200	
*Failing to display a warrant card in a motor vehicle when freedom camping on conservation land on which freedom camping is restricted to self-contained vehicles ¹¹	\$200	\$600	
 While freedom camping a person: interferes or damages the area, its flora or fauna, or any structure, or deposits waste in or on the area (other than into an appropriate waste receptacle)¹² 	\$800	\$2,400	
Making preparations to freedom camp in breach of a prohibition or restriction specified in a notice ¹³	\$400	\$1,200	
Failing or refusing to leave conservation land when required to do so by an enforcement officer ¹⁴	\$600	\$1,800

Infringement offences - LINZ Land			
Infringement offences	Infringement fee	Maximum fine	
*Freedom camping on LINZ land other than where permitted ¹⁵	\$400	\$1,200	
*Freedom camping on LINZ land in breach of restriction or condition in notice ¹⁶	\$400	\$1,200	
*Failing to display a warrant card when freedom camping in a motor vehicle on LINZ land where freedom camping in a motor vehicle is permitted on the condition that the motor vehicle is self-contained ¹⁷	\$200	\$600	
*While freedom camping a person:	\$800	\$2,400	
 interferes or damages the area, its flora or fauna, or any structure, or 			
 deposits waste in or on the area (other than into an appropriate waste receptacle)¹⁸ 			
*Making preparations to freedom camp on LINZ land other than where permitted ¹⁹	\$400	\$1,200	
*Making preparations to freedom camp on LINZ land in breach of restriction or condition in notice ²⁰	\$400	\$1,200	
*Failing or refusing to leave LINZ land when required to do so by an enforcement officer ²¹	\$600	\$1,800

*Displaying an altered or fraudulent warrant card ²²	\$600	\$1,800	
*Presenting an altered or fraudulent certificate of self- containment ²³	\$600	\$1,800	
Refusing to give information when required to do so or giving false or misleading information ²⁴	\$600	\$1,800	

- > The Freedom Camping Act continues to have criminal offences to address serious offending, or example, where a person knowingly discharges noxious or dangerous substances over an area in such a way that it has a significant adverse effect on the environment or intentionally preventing an enforcement officer from carry out their functions and duties.
