# Annex One: Meeting with representatives from local businesses and organisations

- 1. On Tuesday, 22 April 2025, you are meeting with representatives from Glacier Helicopters, White Heron Tours, West Coast Wildlife Centre (collectively are part of the Glacier Tourism Group), Department of Conservation (DoC), local New Zealand Police and St John Ambulance. Biographies of notable attendees are included at paragraph eight.
- 2. The meeting will take place from 4.00pm to 5.00pm and will be held at Rainforest Retreat, 46 Cron Street, Franz Josef Glacier, West Coast.
- 3. The focus of the meeting is to discuss your priorities for the South Island and to gain an understanding of what their challenges are.
- 4. Glacier Helicopters are based in Franz Josef and operate aviation services, such as scenic flights over Franz Josef Glacier, Fox Glacier and Aoraki/Mt Cook. They also offer private charters and commercial services (such as agricultural, heavy lifting, film and photography).
- 5. White Heron Tours are based in Whataroa and operate a tourism business guiding visitors to the Kotuku, White Heron nesting site in the Waitangiroto Nature Reserve (DoC land). They are the only approved commercial business operator into the Waitangiroto Nature Reserve, with entry by permit only.
- 6. West Coast Wildlife Centre are based in Franz Josef and operate a Kiwi welfare centre, initially setting up an incubation and hatching facility for both the Rowi (one of the rarest Kiwi) and the Haast Tokoeka Kiwi. They educate visitors on Kiwi and are involved in repatriating Kiwi back into the wild. They also offer tourist experience packages based around the Wildlife Centre and glaciers.
- 7. West Coast Wildlife Centre recently announced a \$3 million investment to enhance its facilities (briefing REQ-0011908 refers).

#### Poppy and Gus Gordon, Owners, Glacier Helicopters

Poppy is owner and Chief Executive Officer. She is also a line pilot, qualifying as a commercial pilot in 2008. She has experience working in Australia and New Zealand.



Gus is owner, operations manager and lead pilot with nearly 30 years of experience. His expertise is in flying the backcountry experience.



#### Richard Benton, Owner, West Coast Wildlife Centre

Richard is owner and Director. He has owned several businesses in the West Coast and Canterbury regions, primarily in the tourism and conservation sectors.



#### **Dion Arnold, Owner, White Heron Tours**

Dion took over the family business more than 20 years ago and has been guiding for 27-plus years.

#### Annex Three: Meeting with representatives from Westpower Limited

- 1. On Wednesday, 23 April 2025, you are meeting with representatives from Westpower Limited at ElectroNet Group Offices,146 Tainui Street, Greymouth. Biographies of attendees are included at paragraph eight.
- 2. The meeting will take place from 11.30am to 12.30pm and the focus will be on the Waitaha Hydro Project (Waitaha Hydro), which is a partnership between Westpower Limited and Ngāi Tahu (through Te Rūnanga o Ngāti Waewae and Te Rūnanga o Makaawhio)<sup>1</sup>. You will be given a presentation on Waitaha Hydro.
- 3. Waitaha Hydro<sup>2</sup> is a renewable energy project (a 'run-of-the-river' design, reducing environmental impacts) and when completed is expected to generate 25 megawatts, enough to power the equivalent of 12,000 homes.
- 4. Waitaha Hydro is included in Schedule 2 of the Fast-track Act 2024.
- 5. Westpower Limited are owned by West Coast Electric Power Trust on behalf of local electors on the West Coast. They supply electricity to approximately 13,000 customers across the Westland, Grey and Buller Districts.
- 6. ElectroNet Group are specialists in the power industry. The group includes Westpower, Contracting, Consulting and Innovation areas.
- 7. Te Rūnanga o Ngāti Waewae and Te Rūnanga o Makaawhio represent Ngāi Tahu interests on the West Coast.

#### **Peter Armstrong Chief Executive, Westpower Limited**

Peter was appointed to the role of Chief Executive of Westpower in April 2020. Previously, he held the role of General Manager at Mitton ElectroNet for five years.

Peter's background is as a chartered mechanical engineer, and his early career was as a specialist in wind and renewable power generation projects. Since 2010, he has held technical and commercial leadership roles in the transmission and distribution industries, primarily in Australia and New Zealand.



#### Sue Merriman, Chair, ElectroNet

Sue has been a board member since 2001 and has been Chair since 2020.

She is also the Managing Director of Marshal and Heaphy Limited and is a chartered accountant.



#### Rodger Griffiths, General Manager, Generation and Technology

Roger is an engineer with over 40 experience, primarily with the Westpower network and hydro schemes on the West Coast.

#### **Annex Four: Visit to the Snowy River Mine**

- 1. On Wednesday, 23 April 2025, you are visiting the Snowy River Mine (previously known as Blackwater Mine) at Ikamatua, West Coast, from 3.45pm to 4.30pm. Snowy River Mine is operated by Federation Mining Pty Limited (Federation Mining). A list of attendees has not been provided.
- 2. Snowy River is a Tier 1<sup>1</sup> underground gold mine, being developed beneath the historical workings of the Blackwater mine (mined 1906-1951). Snowy River Mine is situated over both conservation and private land.
- 3. The minerals mining permit for Snowy River is held by Federation Mining, operating as Tasman Mining Limited.
- 4. Over the past five years, Federation Mining has constructed twin declines that extend 3.3km from private land at the surface, beneath the conservation estate, to a depth of 700m. From there they have further drilled out the resource (from underground), improving confidence in the mineral resource estimate and collecting data to inform and prepare for mine development. All resource consents and access arrangements required to develop the mine have been obtained. The project currently employs over 80 people.
- 5. AustralianSuper (Australia's largest superannuation fund, with assets of AU\$365 billion) is the majority shareholder in Federation Mining and has invested approximately AU\$200 million to fund the continued development of the mine and completion of the processing plant. Since March 2025, Development West Coast approved an equity investment in the Snowy River Mine of AU\$3 million.

Kānoa – Regional Economic Development & Investment Unit (Kānoa) managed funding

6. Kānoa managed a total of \$15 million for the 'Blackwater Gold Mine Exploration Project' to develop two underground tunnels and ancillary infrastructure to the base of the historic Blackwater gold mine on the West Coast near Reefton. This included exploration work to assess the potential to develop a new modern underground mine.

#### Annex Five: Visit to the Stockton Mine

- 1. On Thursday, 24 April 2025, you are visiting the Stockton Mine at Buller Coalfield (approximately 35 kilometres from Westport) from 8.45am to 9.55am. A list of attendees has not been provided.
- 2. Stockton Mine is owned by BT Mining Limited (BT Mining), a joint venture company between Bathurst Resources Limited (65 per cent) and Talleys Energy Limited (35 per cent) and operated by Bathurst Resources Limited (Bathhurst Resources).
- 3. Stockton Mine is a Tier 1 opencut coal mine (the largest opencut mine in New Zealand), and is located on the Stockton Plateau which is located approximately 25km north-east of Westport. Stockton is the largest employer in the Buller District, employing an estimated 280 staff.
- 4. BT Mining operates three coal mines in New Zealand obtained as part of the Solid Energy liquidation. The mines are Stockton, Rotowaro and Maramarua. BT Mining contract Bathurst Resources to operate each of the coal mines.
- 5. Within Stockton Mine, BT Mining operate multiple open cut pits. BT Mining blends coal in varying quantities from these pits and from third party suppliers to obtain the coal quality specifications required to meet its customer order specifications. This is due to the rapid variation in coal quality properties, where the best coking coal is in the west and the poorest quality coking coal is in the east.
- 6. The mine has 6.4 million tonnes of coal reserves, and in the last financial year, produced 913,000 metric tonnes of coal.
- 7. Bathurst Resources are an Australian based company and began operating in New Zealand in 2011. Their production is mainly used for steel making, both domestically and international, and they have implemented social and environmental practices into their operations. They also operate mines in Southland and Waikato.
- 8. A joint venture company encompassing BT Mining and others successfully applied to have the Buller Coal Plateaux project listed in Schedule 2 of the Fast Track Approvals Act (FTA) 2024.
- 9. The Buller Coal Plateaux project area comprises the existing Stockton and Cypress mines, the existing consented Escarpment and Sullivan pits with new authorisations over Mt Frederick South (an area previously mined). The joint venture announced its intention to lodge its substantive application for the project through the FTA process in June 2025.

#### Annex Six: Information about the West Coast region

#### Key issues in the region

- Opportunities and challenges for the West Coast have been provided previously (briefing REQ-0009653 refers). These include Significant Natural Areas and Indigenous Biodiversity, Infrastructure, investment in infrastructure to attract housing investment, increases to wholesale electricity prices, housing challenges, healthcare, connectivity, energy and airport infrastructure.
- 2. You have also been provided information on the West Coast regional economy, regional priorities and linkages to Government initiatives (including Regional Infrastructure Fund, Going For Growth, Fast-track Act 2024, Resource Management Act 1991 reforms, and City and Regional Deals) in the referred briefing.
- 3. If any queries are raised regarding the above, we recommend you raise these with the relevant minister or officials.

#### West Coast regional economy - update

4. West Coast's Gross Domestic Product<sup>1</sup> (GDP) was approximately \$2.6 billion in the year to March 2024, representing 0.6 per cent of New Zealand's total GDP.

#### **West Coast tourism sector**

- 5. In the year ended October 2024, 7.9 per cent of people were employed in the tourism industry in the Tasman/Nelson/Marlborough/West Coast region. This is compared to 7.7 per cent in the South Island and 6.9 per cent across all of New Zealand.
- 6. Across South Island regions, West Coast is the only region that experienced an increase in domestic spending, at 5.1 per cent, for the period January 2024 to January 2025.
- 7. In the year ended February 2025, West Coast had 1.29 million guest nights, which was slightly lower (4.5 per cent) than the previous year. Overall, total guest nights in the South Island accounted for 42 per cent of total guest nights in New Zealand, which remained unchanged compared to the same month last year.
- 8. In the year ended January 2025, 25.6 per cent of international visitors into New Zealand arrived via a South Island port. The top five countries for international arrivals were Australia, United States of America, Peoples Republic of China, United Kingdom and India.
- 9. According to the ASB Regional Scoreboard Quarter 4 2024<sup>2</sup> report, tourist arrivals are anticipated to increase in the West Coast bringing with it an increase in revenue.

#### **Funding announcements**

#### Regional Infrastructure Fund

- 10. On 7 March 2025, the Minister for Regional Development announced funding of \$15.3 million<sup>3</sup> towards upgrading Hokitika Airport and key port facilities at Greymouth and Westport.
- 11. Hokitika Airport, will receive a \$9.8 million loan towards its \$16.4 million upgrade to help to reduce flight delays and cancellations, reduce aircraft maintenance costs and increase airport operational safety.

12. The West Coast Ports Infrastructure upgrade programme will receive a \$5.5 million loan to upgrade Westport Port and Greymouth Port.

#### Regional Events Promotion Fund

- 13. The Regional Events Promotion Fund (REPF)<sup>1</sup> is a contestable fund that provides \$5.0 million over two years to support the promotion of regional events to the domestic market. The aim of the fund is to encourage regional dispersal and increase visitor spend in the regions with an additional focus on encouraging seasonal dispersal by promoting events outside of the peak summer season.
- 14. In July 2024, Development West Coast were awarded \$153,790 for the following events:
  - Around Brunner \$4,100.
  - Hokitika Wild Foods Festival \$50,000.
  - Ride the Wilderness \$3,250.
  - South Island Ultra Marathon \$4,250.
  - Street Races \$30,500.
  - True West \$31,690.
  - Westside Blitz \$30,000.

#### Regional Tourism Boost Fund

- 15. The Regional Tourism Boost Fund (RTBF) was announced on 20 February 2025. It is a contestable fund providing \$3.0 million (funded through the International Conservation and Tourism Visitor Levy) to support regions to attract more international visitors and encourage dispersal of international visitors around the country.
- 16. Activities funded by the RTBF will be delivered between April and July 2025 and will target Autumn/Winter visitation.
- 17. On 27 March 2025, the Minister for Tourism and Hospitality<sup>2</sup> announced six initiatives to drive international visitor numbers from the top of the North Island to the bottom of the South Island.
- 18. Five of the six initiatives are in the South Island. Information on these were provided to you in the Fortnightly Report 1 April 2025 (briefing REQ-0011908 refers). The following initiatives are related to the West Coast:
  - \$170,000 for a top of the South initiative led by Development West Coast for promotional activities encouraging Australians to visit for luxury experiences.
  - \$600,000 for a central South Island initiative led by ChristchurchNZ for a winterfocused marketing campaign encouraging Australians to travel to the Canterbury and West Coast regions.
