There is already enough controls i.e no access to Schedule 4 land and the Resource Management Act.

Why?

Vast areas of NZ (~34%) are already included in the DoC estate with more land being added i.e. Mokanui River area added to Kahurangi NP. Mining and exploration only accounts for around 0.04% of this area. There is more than sufficient land outside the mining and exploration areas of interest to preserve ecosystems and biodiversity in NZ and the focus should be on schedule 4 land i.e National parks where DoC is struggling to manage these vast resources i.e pests control etc.

Why?

I think Maori interests should be understood and respected and effort made to mitigate any concerns within reason. I think this process currently happens as they are consulted on permit applications, resource consents applications and access arrangements with DoC. Any concerns are considered and addressed if appropriate through this process. Iwi throughout NZ can have very different views and often at odds with each other and within individual Iwi, so it is very difficult to reach a consensus. In the Golden Bay area for example there are 4 Iwi tribes that have very different view on mineral exploration so for and some against. So I think effort should be made to try and reach consensus and accommodate any concerns but the District Plan and RMA should be the overriding decision process as it is now.

Principle: Support the transition to a carbon neutral economy by 2050.

Agree

Why?

This needs to be done responsible and shouldn't be limited to NZ boundaries. If NZ can produce metallurgical coal which is required for steel making and can't be substituted at this stage in a more regulated and environmentally friendly way that other countries then this should be recognised and supported ie.endorsed by the worlds community.
