Why?

Objectives for the minerals and petroleum sector

Objective for a sector that: "Responsibly delivers value for New Zealand (a) Supporting a productive, sustainable and inclusive economy (b) Supporting New Zealand's transition to a carbon neutral economy".

Strongly disagree

Why?

This objective for the sector suggests that the economy is most important. There will not be an economy to consider if we do not act urgently and be mindful of the

environment in everything that we do. We are in the midst of a climate emergency and everything in this strategy should fit into the framework for this emergency.

Objective for a sector that: "Is productive and innovative".

Neither agree nor disagree

Why?

The sector must be innovative to decide how to progress in this climate emergency. While permits have been issued for some purposes, these property rights (and need for profit) can no longer be made more important than the environment. There must be innovation within the sector, and for the sector about how to proceed.

Objective for a sector that: "Is effectively regulated".

Strongly agree

Why?

This sector must be regulated, as business interests have prevailed over environmental interests to date. This balance must change if my children are to have a future. Effective regulation will ensure that the environment is not further damaged.

Are there any other objectives for the minerals and petroleum sector that you would like us to consider in the strategy?

There is no clarity of how the governments policy on climate change: ie to achieve zero carbon by 2050 will be achieved. This must be explicitly stated.

Guiding principles

Principle: The environment, ecosystems, and biodiversity are respected now and in the long term.

Strongly disagree

Why?

the environment, ecosystems, and biodiversity must be protected. The word "respected" is not acceptable. It allows too much room for "flexible decisions" and a balancing of interests. The environment, ecosystems and biodiversity are paramount. This must be a guiding principle.

Principle: Māori cultural interests are understood and respected.

Why?

Principle: Support the transition to a carbon neutral economy by 2050.

Strongly agree

Why?

there will be no economy unless we achieve carbon neutrality by 2050. This must be the guiding principle.

Principle: The impact on people, communities and regions are managed in a just and inclusive way.

Why?

there will be an impact on people and communities in achieving a carbon neutral state. The generations that follow us need us to do this. We need to think creatively about how to manage the impact this will have on people, communities and regions.

Principle: Support a circular economy by meeting resource needs through resource efficiency, recycling and reuse.

the circular economy should be a strategy on its own. As it stands there is ip service to the idea, but no actual steps about how to get there

Principle: Actions taken within the mineral and petroleum sector should align with the strategic direction of other related sectors and Government strategies.

Why?

Everything in this strategy must align with the framework of the climate emergency. There is no point in aligning this strategy with other related sector and Government strategies. The climate emergency strategy MUST be the priority strategy.

Why?

The Crown must regulate in a transparent way: toward achieving carbon neutrality by 2050

Principle: The Crown honours the rights of current permit holders to continue production or exploration activities under existing permits.

Strongly disagree

Why?

BAU isnt an option any more. These permits must be revisited. Times have changed. Our whole world is at risk and permits must be reconsidered in this light. Fracking is not ok: there is alot of research about this. We know more about the implications of current permits and their use now, and need to make sure that the activities allowed for by them, are consistent with achieving a carbon neutral status by 2050: if not, the permit must be revoked.

This draft strategy is not consistent with the Government's policy on climate change. We have to achieve zero carbon by 2050. This strategy has to fit with the framework of the climate emergency we are living in. It cannot ignore it. BAU is no longer an option. The draft policy does not reflect that simple fact.

Mining of all resources must be dependent on environmental impact. The use of gas is no a sustainable bridge to a low carbon economy. We have to think differently about whether or not we need to mine, and if we need the resources. We have to be clear about phase-out times for fossil fuels. There are good substitutes for these fuels: lets research and develop them.
