That petroleum use is drastically reduced and coal use virtually stopped in NZ. We need immediate action to build new sustainable energy sources. The electricity system needs to return to state control so that the needs of share holders (a few) no longer take precedence over the needs or the rest of the NZ and the world..( the many). The proposed strategy makes little distinction between fossil fuels, use of which should go to zero as soon as possible because they are causing climate change, and other minerals which should also be assessed on their community, regional and environmental impacts.

The climate change needs to be seen as a real emergency needing emergency responses.
