Why?

No distinction is made between fossil fuels and other minerals. Fossil fuels should go to zero as fast as possible, because they are driving climate change. Other minerals should be assessed on their environmental impact. No distinction is made between aggregates, which are abundant and can usually be mined with low impact, and minerals like gold which cause disproportionate environmental disruption. Metals essential for the transition to a zero carbon economy (eg lithium, cobalt) should be given priority over those which are merely "nice to have" (eg gold – there is enough gold already above ground for essential industrial uses.)

What is your vision for the minerals and petroleum sector in New Zealand?

The draft Strategy should be consistent with the Government's policy to achieve zero carbon by 2050 under the Paris Accord. Everything in the Strategy must fit within the framework of the climate emergency and the need to change the ways we do things. Last year the United Nations said we had 12 years to sort out emissions, so business as usual is not an option any more. Principle 1 says that ecosystems and biodiversity must be "respected". That must include climate change, which should not be disrespected.

How can New Zealand sustainably derive value from its petroleum and minerals resources?

By sustainably conserving them for uses for which they are unique.
