Principle: The impact on people, communities and regions are managed in a just and inclusive way.

Why?

We will not achieve the fine goals without a better people involvement

Principle: Support a circular economy by meeting resource needs through resource efficiency, recycling and reuse.

Why?

Planet earth has great, but finite resources; great care is needed with them

Principle: Actions taken within the mineral and petroleum sector should align with the strategic direction of other related sectors and Government strategies.

Linking: community/ stakeholders/ legal meetings and consultation with continued external monitoring. The legal, contractural obligations will need to be 'watertight' whilst the mining operation needs to be able to be reviewed in a creative way. Mining is a dynamic industry calling for drastic intervention at short notice. A strict application of law might not suffice where human lives and ecological welfare are threatened

Action Area: Research and investment in better mining and resource use

Understanding and money are surely needed. These are not enough to ensure the desired goals, however. There are still further human factors: apprecaiting where,

what and how to mine. These are moral and ethical considerations, requiring a different set of skill and application
