Why?

Given the damage that we are still doing to our Earth, there is no future for a petroleum sector. The only option we have to mitigate catastrophic climate change is to stop releasing carbon from oil that was created over millions of years. Social responsibility also requires us not to jeopardise the ability of future generations to live meaningful lives, ie not destroy the planet.

What is your vision for the minerals and petroleum sector in New Zealand?

The petroleum sector needs to completely re-invent itself into a truly environmentally sustainable energy sector. Mineral extraction industry should not be export focused: Our minerals are our taonga, and should only be extracted for cultural and local survival needs, and must be done without releasing more greenhouses.

How can New Zealand sustainably derive value from its petroleum and minerals resources?

The world situation we have created means petroleum and sustainability are mutually exclusive. Mineral extraction will only be sustainable at much less intensive levels than current.
