Principle: The environment, ecosystems, and biodiversity are respected now and in the long term.

Strongly agree

Why?

"Respect" is not enough, we must protect our environment, ecosystems, and biodiversity. This are essential for a sustainable, healthy, and liveable future.

Principle: Māori cultural interests are understood and respected.

Strongly agree

Why?

Iwi and hapu must have input into whether materials can be extracted from a region.

Principle: Support the transition to a carbon neutral economy by 2050.

Strongly agree

Why?

This is essential and ideally should aim for sooner that 2050.

Principle: The impact on people, communities and regions are managed in a just and inclusive way.

Strongly agree

Why?

It is very important that we help communities with a just transition away from fossil fuel industries. This will require government support.

Principle: Support a circular economy by meeting resource needs through resource efficiency, recycling and reuse.

Strongly agree

Why?

We need to go beyond lip service here. We need to build a sustainable circular economy that focuses on reuse and recycling. Give this principle its own strategy.

Principle: Actions taken within the mineral and petroleum sector should align with the strategic direction of other related sectors and Government strategies.

Strongly agree

Why?

This sector must comply with the general strategic direction of the government, especially around policies such as the Zero Carbon Bill. Te draft strategy is not consistent with the general direction. Business as usual is no longer an option, we must change the way we do things.

We should not accept any form of this for fossil fuels; for other resources it should be considered based on their environmental impact.

Principle: The Crown makes policy decisions based on the best evidence, and accounting for the foreseeable need for minerals and petroleum, both now and for future generations.

Our main focus must be on rapidly phasing out fossil fuel extraction. Permits for extensions and new exploration must stop immediately.

Gas is not a sustainable bridge to a low carbon economy. Its emissions are not much better than coal (60%), and the production and use of gas results in significant methane emissions.

The strategy must set a time-frame for phase-out of fossil fuels. It can begin with uses where there are good substitutes, like electricity generation. Other uses without good substitutes (like steel making) could have longer to phase-out, while clean alternatives are researched and introduced.
