Why?

It's hard to disagree with such a bland and meaningless vision statement. However, the only way in which the minerals and petroleum sector could be remotely environmentally and socially responsible would be for the extraction of fuel coal and oil to be reduced rapidly. Other fuel components, such as natural gas and LPG may continue to be extracted at a reducing rate as important transitional fuels. Some minerals may become important in a renewables based economy - such as the socalled rare earths and lithium. And we will continue to need concrete, glass, etc.

What is your vision for the minerals and petroleum sector in New Zealand?

One that puts the effects of CO2 emissions first and foremost. Meaning a sector that will rapidly diminish in size and importance unless it is contributing to a renewables based economy. Off-setting is not a viable answer, genuine deep sequestration of CO2 is an answer, but has not been demonstrated at the necessary scale. Also, every sector appears to be using off-setting instead of genuinely reducing actual emissions. An excuse for business as usual.

How can New Zealand sustainably derive value from its petroleum and minerals resources?

By developing and promoting those minerals that support renewable energy - such as lithium. Not coal and oil as fuels. Minimal necessary extraction of gas to support transition. Minimal extraction of things such as sand, aggregates, and iron-sand.

The word 'just' is very slippery in that we do not keep jobs for the sake of jobs. But just in that we support transition to employment in other sectors. This sector is going to necessarily experience disruption and pain.

Why?

Hard to see this as a very principle for what is, essentially, a purely extractive sector. Misappropriation of a very important idea.
