Taranaki Crossing Taranaki \$13.5m The \$13.5 million of potential PGF funding is awaiting a final approval by the Ministers of Regional Economic Development in July/August (TBC) and the Minister of Conservation. There is growing concern in the region that further delays in this project may mean that any physical works cannot begin for spring/summer weather. There is also desire amongst various iwi to get certainty about whether it will proceed so they can develop their own economic aspirations related to the upgrades of the Crossing.
