2. PROVINCIAL GROWTH FUND UPDATES

2.1 Provincial Growth Fund weekly update

On 16 April 2018, the Provincial Development Unit (PDU) implemented PipeDrive, a cloud-based client relationship and pipeline management system. This tool will support the PDU to generate greater efficiencies, as well as providing the ability to easily track, monitor and report on Expressions of Interest (EoIs) and applications. The PDU is in the process of transferring EoIs and applications to PipeDrive As at 26 April 2018, there are 55 EoIs and applications in the PipeDrive system. Queries received regarding the PGF are not managed in the PipeDrive system.

2.2 Wairoa

On Friday 20 April John Sproat, an Independent Advisory Panel member joined PDU officials to meet with Craig Little, the Mayor of Wairoa and Steven May, Chief Executive of Wairoa Council. The Mayor outlined the PGF priorities for the region, and gave his view of the challenges and opportunities for regional economic development. John Sproat emphasised the need to maintain regional cohesion and to share PGF applications with the Hawke's Bay Matariki Steering Group.

The PDU will increase its support for the region in order to progress applications for funding from the PGF. Officials will provide an update to the Minister at the Regional Economic Development officials meeting on 2 May 2018.

2.3 Process and timeframes for assessing applications

The PDU is aware of some concerns in the regions about the timeframes for assessments and decisions on applications for funding. Following due process for assessing applications is important to ensure consistency in decision-making, fairness to all applicants as well as integrity of the decision-making process. It is also important that the PDU's processes are robust to withstand scrutiny.

The PDU is committed to making decisions in a timely manner and changes have recently been

made to increase timeliness for responding to queries and assessing applications. The changes include:

- The introduction of PipeDrive a cloud-based client relationship and pipeline management system to accelerate the triage process of EoIs and applications
- Developed and implemented new EoI, application and evaluation documents
- Increased capacity within the PDU to process applications.

The service standard target is for an initial review and triage of applications to be completed within 5 to 10 working days. As officials develop an understanding about the different types of applications, work to develop timeframes specific to the Investment Tier and the value of the investment will be undertaken. Where proposals are complex or seeking a significant amount of funding, timeframes may be longer.



3. PROVINCIAL DEVELOPMENT UNIT UPDATES

3.1 Appointment to the Provincial Development Unit Leadership Team Nigel Bickle Privacy of natural

On 24 April 2018, AJ Millward was appointed the General Manager – Strategy and Governance. AJ was the General Manager responsible for establishing the Pike River Recovery Agency at MBIE. AJ will join the PDU on Monday 30 April. The Strategy and Governance Branch will have five key functions: strategy and evaluation, planning and reporting, governance and ministerial support, risk and assurance and communications and engagement. As noted last week, officials are working with other agencies, including Treasury, on the detail of resource requirements across government agencies to support the PGF. A briefing will be provided to you in May.

4.1 Forest Economic Advisory (FEA) Report

MBIE has commissioned Forest Economic Advisors (FEA) to provide an international commercial perspective on factors influencing the competitive position of New Zealand's wood processing industry (the project). This will assist the government's understanding of the industry in the context of its regional development and economic development objectives.

New Zealand Trade and Enterprise's Investment team and the Ministry for Primary Industries (MPI) were consulted on the commissioning of the FEA project. The project will inform other areas of work that MPI currently has underway on the wood processing sector, for example; work to identify options for improving the security of log supply for domestic wood processing, analysis of options for increasing the use of wood, and a report to the Cabinet Economic Development Committee on current issues in the forestry sector [CAB-18 MIN 0084 refers]. FEA will contact a number of industry participants to discuss their perspective.
