2. PROVINCIAL GROWTH FUND PROGRESS UPDATES

2.1 Provincial Growth Fund Weekly Update

Robert Pigou Privacy of natural persons

As at 31 May 2018, 215 projects had been logged in RipeDrive. This is an increase of 18 from last week. Of the 215 projects, 103 are Expressions of Interest (EoIs) and 112 are Applications.

We can confirm that all applicants for both the EoIs and Applications have been personally contacted and are all under active management.

An overview of the pipe-line projects, and their status, will be provided in next week's report, including analysis by sector, region and tier.

3. INFORMATION ON UPCOMING PROVINCIAL GROWTH FUND PROPOSALS

The Senior Regional Officials group approved investment of up to \$297,000 for continued design and development work for the Museum. This investment allows the recipient to continue work up until the next request for PGF funding.

The business case for the Museum will be considered by the Waitangi National Trust Board at its meeting on 15 June 2018. Subject to Board approval, the business case will form the basis for its request for capital funding for the Museum from the Provincial Growth Fund (PGF), which will be presented to the PGF Ministers Group for consideration on 2 July 2018.

The Waitangi National Trust is awaiting confirmation from Far North District Council on its resource consent application. The Trust lodged its request as non-notified on 15 May 2018.

The Waitangi National Trust has completed its initial round of engagements with representatives of A, B, C and D companies. Officials have been informed that A Company Te Taitokerau Association has passed a resolution in support of a national museum commemorating the 28th Māori Battalion at Waitangi. Consultation by company representatives within their regions is underway, but is unlikely to have been completed by 2 July.

Privacy of natural persons and Privacy of natural persons are being contracted by the Provincial Development Unit (PDU) to engage with the descendants of 28th veterans to garner their support for the museum

project. They will also engage with A, B, C and D Company representatives and other key stakeholders e.g. Ngāti Porou.

In view of the above factors, a decision to release capital funding is expected to be conditional on success of the resource consent and support from the companies.

PDU will report-back once information is available regarding timeframes for the resource consent process, the Waitangi National Trust Board's decision on the business case, and progress with the Trust's consultation with the companies.

4. REGIONAL ECONOMIC DEVEOPMENT UPDATES

4.1 Silviculture update

Hinemaua Rikirangi

Updates on the reported labour shortages in the silviculture industry in the Wairoa district are outlined below. This is linked to requests for support to bring migrant labour in to the region [MBIE 3523 17-18 refers].

4.1.1 Hawkes Bay/Wairoa, East Coast/Gisborne Regional silviculture labour shortage and opportunities

Initial reports received from small businesses in the Wairoa district indicated a labour shortage. Further review indicated specific requests came from Gisborne based business owners and contractors including Vailea Silviculture, Mac Kapene, Lydia Edwards and Hikurangi Forest Farm. While these businesses are Gisborne based, the issue of labour shortage for the forestry industry (and horticulture) could be a regional issue.

To better understand the regional situation, meetings are being held over the next two weeks with a number of key stakeholders from Hawke's Bay iwi and hapū including ^{Privacy of natural persons}, and possibly ^{Privacy of natural persons}.

The purpose is to scope the issue, the opportunities for employment and training and fully appreciate the complexities that they are operating in. Also to gain information about existing initiatives already operating in the rohe, whether these can be leveraged and what role stakeholders could play in addressing the labour shortage issue.

Follow-ups are being progressed with Gisborne based forestry businesses, and with and Privacy of natural persons who have local knowledge and involvements with forestry and training within the Tairawhiti.

Once we have a better understanding of the situation and have identified the key parties involved we will work together to determine whether the immediate issue of forestry shortage is able to be addressed. We will also scope opportunities together with a broader range of local stakeholders, including government, businesses, tertiary education provider/s, hapū/iwi providers and agencies for the development of initiatives and strategies to address medium to longer-term sustainable local employment.

4.1.2 Immigration Applications

Recent discussions have taken place with independent immigration advisor, ^{Privacy of natural persons} who is based in Wairoa. ^{Privacy of natural has strong views that there is a need for migrant labour across the region that is not able to be filled locally. She advocates for a change to enable a 'special forestry industry visa' to respond to the immediate local forestry business need. ^{Privacy of natural} has not yet linked in with iwi, hapū, or local organisations that are working with potential employees.}

4.2 Māori Economic Development Advisory Board appointments:

Hinemaua Rikirangi Privacy of natural persons

There are currently eight Māori Economic Development Advisory Board (MEDAB) members (three of which have terms scheduled for reappointment) and two vacancies.

The terms of three members ended in late March 2018 and these members are available for reappointment and supported by the MEDAB Chair. As proposed (2544 17-18 refers) members re-appointed will be appointed for staggered terms to provide continuity and more timely transition arrangements in future.

Following confirmation of yours and Minister Mahuta's preferred candidates for the two vacancies, we will contact them and prepare the necessary documentation for you to lodge papers with Cabinet office for the 20 June 2018 APH committee meeting.

4.3 Report on socioeconomic deprivation in the Waikato region

Stephanie Weller Privacy of natural persons

A report entitled "Socioeconomic Deprivation in the Waikato Region: Using the Index of Multiple Deprivation to understand drivers of deprivation" has just been published, and shows that districts and communities within the Waikato region rank amongst the most deprived areas in New Zealand. The report was compiled as a tool to help drive decision-making for targeting funding and initiatives to improve social outcomes.

The report uses the New Zealand Index of Multiple Deprivation (IMD), released by the University of Auckland last year. The IMD was developed using data from government departments, Census statistics and methods comparable to current international deprivation indices to measure different forms of disadvantage. It looks at 28 indicators which are grouped into seven domains of deprivation: employment, income, crime, housing, health, education, and access to services.

Highlights from the report include:

Two Walkato districts - South Walkato and Hauraki - are amongst the twelve most deprived districts in the North Island, with more than 40 per cent of their population living in the top quintile for deprivation.

A total of 70 per cent of the Hauraki population are living in either deprivation 4 or 5 quintiles (high and very high deprivation). South Waikato and Waitomo follow with 68 per cent of their population living in deprivation quintile 4 or 5.

- Within the region, South Waikato district has the most people living in areas with quintile 5 (very high) employment deprivation at 71 per cent.
- South Waikato also has the highest percentage of population living in quintile 5 for income deprivation at 46 per cent, followed by Hauraki at 39 per cent.
- Hamilton City has the 2nd most deprived data zone in New Zealand for income (out of a total of 5958 data zones across New Zealand).
- The Waikato region ranks worse than the New Zealand median for education deprivation. South Waikato has the highest percentage of people living in quintile 5 data zones for education deprivation at 64 per cent. Hauraki follows with 47 per cent and Waitomo at 42 per cent.

The report will now be used by regional stakeholders, including councils and District Health Boards, to target funding and initiatives at local communities. It will also inform the South Waikato Action Plan work which is currently underway with South Waikato, Waitomo and Otorohanga districts.
