# **1.** WAIRARAPA DARK SKY RESERVE

## We recommend that the SROs:

- a) Approve \$100,000 from the PGF fund towards Wairarapa Dark Sky Reserve international certification project, subject to further discussions with Commercial Information
- b) Note the applicant has advised that obtaining accredited status for the reserve is dependent on provision of an independent economic assessment of what accreditation status would provide for the region.
- c) Note the \$100,000 spught would be allocated across the following major deliverables:
  - \$<sup>commercial Infr</sup> for an economic study;
  - Scommercial infor development of an economic plan; and
  - \$<sup>commerc</sup> Viniting of the business case.
- d) Note that grant funding is recommended on the basis that the applicant is a voluntary/not for profit organisation and has limited access to other sources of funding and there has been limited PGF funding granted to Wairarapa related projects to date.
- e) Note that although the applicant is seeking an <sup>600</sup>% contribution from the PGF for the project, there has Commercial Information

### Proposal:

Funding is needed to undertake an independent economic assessment of the benefits of obtaining accreditation for a new gold standard international dark sky reserve providing for an astronomy tourism attraction in the Wairarapa.

To attain accreditation status, applications are required to be submitted to the International Dark Sky Association and assessed against its eligibility criteria. The accreditation association has six application submission deadlines per year and there is an expectation that it will take a maximum of 2 months to confirm whether or not the proposed reserve meets the required criteria to gain accreditation. The applicant has received confirmation from the accreditation association that the submission will be considered in accordance with the 2018 eligibility criteria. However there is a risk that this may lapse if the submission is not made as soon as possible and could result in further delays and additional costs. Accreditation status would place the reserve alongside 13 other reserves worldwide and would increase the Wairarapa region's attractiveness as a tourist destination for astronomy enthusiasts. This would be complementary to other tourism related activities/attractions in the region such as food and wine, hot air ballooning and aviation –particularly in the off-season. Tekapo is the other NZ reserve with accreditation status.

## Assessment against the PGF criteria:

### **Eligibility Criteria**

No issues.

#### **Productivity Potential**

Establishment of accreditation status for the reserve is likely to result in the need for further PGF investment in facilities to realise the full productivity potential, including job creation in the wider tourism sector including accommodation, hospitality and tour operators.

#### Analysis of the benefits and costs

- The application is for the development of an independent economic assessment which is needed to support the accreditation application.
- The creation of a dark sky reserve in the Wairarapa will provide diversification and a complimentary tourism offering for a region rich in food and wine production. This tourism product has been highly successful in Tekapo NZ and continues to grow. The product also has the benefit of being year round (some of the best viewing being in winter) which stretches the traditional NZ tourism season.
- Additional tourism, especially balancing the season, has widespread economic benefits for supporting sectors such as accommodation, hospitality, tour operators, and supporting services.
- The sector, being new to the region, will help in the creation of new jobs if accreditation is obtained.

#### **Financial Analysis**

The applicant is an incorporated society and reliant on voluntary contributions /grants for funding of activities.

#### **Funding Arrangements**

Applicant is seeking \$100,000 in grant funding from the PGF out of a total cost of \$ needed to undertake the study needed to apply for accreditation status. Significant additional funding is likely to be needed to realise

But in saving this, the proposal strongly aligns well with a key element of the tourism strategy as it should help attract tourist in the off-season. This could result in tourism providers improving their utilisation rates in the off-season (it is often very difficult to come up with initiatives that do this).

The dark sky initiative appears to be looking to take good use of the natural comparative advantage Wairarapa has over other regions.

The proposal appears well put together and comprehensive. Given the "public good" (i.e. non-excludable and nonrivalrous) of a "dark sky" proposal it is understandable they are seeking government assistance.
