### **Insolvency Practitioners Regulations**

Portfolio Commerce and Consumer Affairs

On 23 June 2020, the Cabinet Legislation Committee:

- **noted** that in February 2020, Cabinet Economic Development Committee:
  - 1.1 agreed to implement the licensing and registration scheme introduced by the Insolvency Practitioners Regulation Act 2019 and Insolvency Practitioners Regulation (Amendments) Act 2019, including setting fees and a levy;
  - authorised the Minister of Commerce and Consumer Affairs to approve minor and technical changes on issues arising during the drafting process;

- 2 **noted** that the Insolvency Practitioners Regulations 2020 and the Companies (Reporting By Insolvency Practitioners) Regulations 2020 give effect to the decision referred to above;
- anoted that the Minister of Commerce and Consumer Affairs has approved two drafting decisions to address issues highlighted during drafting;
- 4 **noted** that the backstop dates for the commencement of the Insolvency Practitioners Regulation Act 2019 and Insolvency Practitioners Regulation (Amendments) Act 2019 have been amended from 17 June 2020 to 1 June 2021 to allow for COVID-related delays by the COVID-19 Response (Further Management Measures) Legislation Act 2020;
- agreed to the remaining provisions of the Insolvency Practitioners Regulation Act 2019 and the Insolvency Practitioners Regulation (Amendments) Act 2019 that have not already been brought into force, as well as the Insolvency Practitioners Regulations 2020 and the Companies (Reporting By Insolvency Practitioners) Regulations 2020, coming into force on 1 September 2020;
- agreed to the promulgation of an Order in Council under the Insolvency Practitioners Regulation Act 2019 and an Order in Council under the Insolvency Practitioners Regulation (Amendments) Act 2019 to make the commencement date 1 September 2020;

- 7 **authorised** the submission to the Executive Council of the:
  - 7.1 Insolvency Practitioners Regulation Act Commencement Order 2020 [PCO 22946/2.0];
  - 7.2 Insolvency Practitioners Regulation (Amendments) Act Commencement Order 2020 [PCO 22947/2.0];
  - 7.3 Insolvency Practitioners Regulations 2020 [PCO 22647/6.0];
  - 7.4 Companies (Reporting By Insolvency Practitioners) Regulations 2020 [PCO 22668/3.0].
