1. Taskforce

Ministers noted and agreed to all recommendations.

The Chairs advised Ministers that they want the Taskforce to engage beyond the Tourism sector, for example with conservation. They described the concentric circle model, whereby the Taskforce itself is small and not seeking to be representative, with a large representative outer circle providing information and perspectives. It was agreed that the short term recovery phase initiatives should reflect, where possible, the longer term aspirations for the sector.

MoF noted s 9(2)(a)

, and that

smaller tourism operators will need to see themselves reflected in the Taskforce. Tak Mutu was mooted as an operator who does an exceptional job of connecting conservation and tourism. Ministers agreed that he be approached by Steve Chadwick to be an additional taskforce member to those proposed.

Ministers noted that only the core Taskforce members (co-Chairs and Independent Members) would be remunerated.

## 2. STAPP

Ministers noted and agreed to all recommendations. It was noted that the timeframe for the STAPP process is ambitious. MBIE suggested proven processes could be adopted from the PDU.

3. Tourism New Zealand update
