# Further Regional Business Partnership Advice for Small Businesses

## Portfolios Economic Development / Small Business

On 17 June 2020, the Cabinet Economic Development Committee, having been authorised by Cabinet to have Power to Act [CAB-20-MIN-0286]:

- **noted** that COVID-19 funding of \$15 million for business advice, provided through the Regional Business Partner network in April 2020, is now fully committed;
- 2 **noted** that this funding, provided as vouchers (to a maximum of \$5,000), has primarily been utilised by smaller firms (with over 90 percent by firms with fewer than 20 employees) to ensure business continuity and survival;
- noted that there is still a significant unmet pipeline of demand for these services, and they will play an important role in business recovery over the coming months;
- 4 **agreed** to the additional funding of \$40 million for business advice provided through the Regional Business Partner network, subject to the decisions by Budget Ministers on the next COVID-19 Response and Recovery Fund round;

## Confidential advice to Government

- 6 **noted** that a survey of impact of the programme will start in June 2020 and will report in July 2020 (surveying in June 2020 gives firms the chance to use the voucher and identify what benefits are accruing from the new information they have learned);
- noted that New Zealand Trade and Enterprise will undertake an audit of business advice services in September 2020, and will forward the results of the audit to the Minister of Finance, the Minister for Economic Development, the Minister of Research, Science and Innovation, and the Minister for Small Business;
