Entity Detail:	Moana House is a well-established residential therapeutic community based in Dunedin, which caters for adult male offenders and those who have a history of alcohol or drug abuse. It is run by the Downie Stewart Foundation, a registered charitable trust originally established in 1987. It operates from an ordinary house in the suburbs of Dunedin, and currently can accommodate up to 17 people at a time.		

We recommend that the SROs:

- a) Recommend to RED Ministers to approve \$1,036,507.00 from the Social Capital Investment portion of the Provincial Growth Fund (PGF) towards the Te Hautū Project.
- **b) Note** that the project aligns with the Social Capital Investment objectives of strengthening labour supply and building community resilience, by:
 - assisting people to overcome substance addiction and related issues, and
 - preparing them to re-join the workforce.
- c) Note that PGF funding is required to fund upgrade of premises, work and study support programmes, improvement of resources, and increased after care services. Commercial Information
- d) Note the funding requested is a grant for Commercial Information
- e) Note Moana house is a well-established organisation, with proven expertise and experience in delivering treatment and support programmes to reduce the harm of substance abuse to individuals and whanau.
- f) Commercial Information
- **g) Note** the applicant is the main provider of this service not just in the South Island, but the whole country and has demonstrated wide support within the region and community.
- h) Note the proposal is "shovel ready" and can start immediately, with all the consents (resource and building consents), new staff resources readily available and insurance required already in place.
- i) Note all people joining the residential programme usually start engaging in 2 days of work per week within 2 weeks of the programme, unless in case of medical issues or significant risk perceived
- j) Note that Due Diligence needs to be conducted for the applicant

Background:

Moana House is a well-established residential therapeutic community that provides a national long-term treatment and rehabilitation service catered for a specialty whaiora (client) group. Those who come to the Moana House have multiple addiction and co-existing difficulties such as: substance abuse, poor relationships, are victims or perpetrators of violence, have poor work skills, significant histories of recidivist offending, gang connections, wide range of whanau difficulties (including domestic violence), ongoing health problems including some mental health issues and difficulties in setting and achieving goals.

Moana House provides a supportive family environment and a safe place to change, and has a reputation for delivery of these services to a very high standard. A vital aspect of the wraparound service provided is the lack of time limits on support, as this can be an additional stumbling block for many who find it difficult to survive on their own.

Target Group

The rehabilitation and reintegration programme run by Moana House is specially designed for adult males who present a high risk of recidivist offending and/or have significant history and issues involving substance abuse.

Proposal and Funding Detail

Moana House plans to continue providing a comprehensive wraparound service which includes ongoing training, study and work opportunities. PGF funding is required for 3 key elements not currently covered by other sources and that are linked into supporting the wider Moana House programme. These include:

1) Upgrade of premises:

Funds are needed to upgrade their current premises to ensure they have the appropriate infrastructure to increase capacity, provide more and enhanced services and to live and work in an ordinary community in High Street, Dunedin, where the men get the chance to live in an "ordinary whare" as opposed to other institutional-like settings. Two of the three spaces are already funded by other sources.

Consents are already in place, and local businesses have been engaged for the renovations, which can start immediately and would be completed within Commercial Information.

2) Work and study support upgrade and improve resources:

Academic Support:

The roles have been developed so work can be combined with study and Commercial Information part time men who will all get a chance to step up in this line of work while combining it with their retraining at Otago Polytech.

Funding is sought to also cover Commercial Information to assist two of the men getting the support they need for their Level 4 Health bridging programme; hiring Commercial Information and purchase the required Driving Instructor hours to ensure the men get their licences which is seen as a major barrier in getting employment

Truck and trailer upgrade:

A key component of the programme greatly in need of upgrading to ensure they can continue their work programme operates effectively and efficiently adhering to health and safety requirements. The truck and trailer is used to transport the equipment used by residents to sites and to take green waste to the dump and additional workday support.

3) Increased After Care Services:

Study support and work brokering:

A temporary premises will be acquired for rental. This new premises will allow the continuity of the Study support and Work brokering services provided during the final stages of construction. It is envisaged that this will only be for maximum or until the new venue is completely fitted out to an appropriate

standard.

The fit out will allow more residents to participate in the program as well as be able to receive the 1:1 support or training as required.

COVID-19 response

- Systems are in place once the new build opens providing much more space.
- Sign in systems are in place for contract tracing as well as gloves and masks at the door on way in.

Wider outcomes and social benefits

- Reduce recidivist offending by providing long term support, in-depth therapy and constructive skills that can translate into real life.
- Provide positive opportunities for those in the justice and corrections systems to consider change as a
 real possibility, as often the people who go through the programme have already been declined support
 elsewhere.
- Develop positive sense of identity and belonging via targeted cultural interventions.
- Reduce reliance on the welfare system, by encouraging and building confidence to break "benefit dependence" intergenerational cycles.
- Build and improve resilience of families and communities, often facilitating family reconnections.
- Promote active participation in the labour market, and prepare participants to re-enter the workforce by delivering skills training (e.g. first aid, licenses, chainsaw certificates, catering and kitchen experience).
- Facilitate transition into employment through specialised employment brokerage and by developing relationships with employers and recruitment agencies.
