The funding is for infrastructure for a 165 hectare "green industry" development near Kaikohe, which aims to create new approaches to environmental sustainability and carbon neutrality, economic growth, and social equity in the region.

3.2 Other projects

Ōpōtiki Harbour Development Project	Survey work on the rivers and the offshore seabed commenced last week. Full development of the Osborne's quarry site is underway, initially supplying rock for the mussel factory site and for the access roads and then building a stockpile of rock for the harbour walls. Archaeological authority has been issued and this allows the construction of the access roads to the harbour to commence in commercial information. This will then allow Commercial Information to commence compaction works on the harbour wall foundations in commercial information , which will inform the final design. A sod turning/karakia ceremony for physical works occurring on site is planned for the end of June.

Kai for Kaipara Water – Phase1B	The project is progressing well, with the focus to date on identifying potential sites and an evaluation to select two demonstration sites to showcase practical working examples of irrigating high-value horticultural crops. 4. Other updates

4.1 Te Ara Mahi (TAM) / He Poutama Rangatahi (HPR) update

Regional Apprenticeships

Regional Economic Development Ministers will consider the regional apprenticeships package on 18 June 2020. The PDU is finalising a report on the regional apprenticeships package which will be with your office in the coming week for Ministerial consultation. The recommendations will give you delegated authority to approve applications and other details, as necessary. We also continue to work on potential applications to include for approval at that meeting and endeavour to have payments paid upfront as much as possible to assist businesses in the current climate.

The PDU has also been working with other government departments on the broader apprenticeship initiatives. We understand that a draft Cabinet paper on Apprenticeship Support and the expansion of Mana in Mahi will be discussed at the next Employment, Education and Training (EET) Ministers' meeting on Monday 8 June. This paper proposes a single unified approach to all apprenticeship initiatives Commercial Information to provide clarity to employers. The PDU supports this approach.

The regional apprenticeships package is also outlined in the draft Cabinet paper and includes details of the wage subsidy of some in the first year and some in the second year, the additional funding set aside to support employers and apprentices, and administration costs. Some Ministers may raise equity issues around the regional apprenticeships wage subsidy to employers being higher than other apprentice wage subsidy amounts. However, the regional apprenticeships package will be targeted to Māori and Pasifika who are known to have greater labour market disparities, the higher wage subsidy will aim to lessen that disparity.
