## Recommendations

---

*The Provincial Development Unit recommends that you:*

- a) **Note** that the PDU has received a significant volume of applications for worker redeployment projects. These exceed the initial funding that was proposed for such projects. In particular, the PDU has assessed another 270 marae renovation proposals and these are recommended for funding in this briefing.
- b) **Note** that the previous marae approval briefings provided to Ministers had more detail on the individual projects. Given the number of marae being considered for approval in this briefing, less detail has been provided. However, the PDU can confirm they have undertaken the level of analysis required for the in principle approval requested. In particular the PDU can confirm that all 270 projects have been reviewed and based on the information provided we can confirm they align with PGF COVID-19 redeployment criteria. The quotes provided by the applicants show the projects:
  - i. Provide immediate job creation and income growth;
  - ii. Indicate construction activity that will be underway in the next 6 months; and
  - iii. Will provide a high degree of visibility to the community to give the public confidence that renewed economic activity is underway.
- c) **Note** that the marae renovations recommended in this briefing will be subject to on-going analysis and the usual PDU contracting provisions including;
  - i. Procurement to the satisfaction of PDU (this includes subcontractors);
  - ii. Confirmation of final costs;
  - iii. Satisfactory due diligence;
  - iv. Satisfactory financial analysis;
  - v. Advice from Te Puni Kokiri;

### d) Commercial Information

- e) **Note** that a provision of up to 10% contingency of the total project costs for each individual marae has been included in the recommended funding, if deemed necessary by the PDU to complete the project
- f) **Note** where necessary the PDU will apply further conditions of funding such as, confirmation that building consents are not required or have been obtained for the proposed renovation work.
- g) **Note** the total investment in marae renovation projects to date is \$<sup>Commercial Information</sup>. This includes:
  - i. \$<sup>Commercial Information</sup> for <sup>Comme</sup> marae (PGF Funding)
  - ii. \$<sup>Commercial Information</sup> for <sup>Co m</sup> marae (Worker Redeployment Package Appropriation)
- h) **Note** that there is currently a balance of \$<sup>Commercial Information</sup> in the Worker Redeployment Package Appropriation.
- i) **Note** that \$5,000,000 of this Worker Redeployment Package appropriation has been ring fenced for an MBIE led worker redeployment project.
- j) **Note** that Ministers have received a briefing for consideration recommending approving \$750,000 from the Worker Redeployment Package towards the Tuki Tuki Cycle Trails project.

- k) **Approve** \$<sup>Commercial Information</sup> of the Worker Redeployment Package Appropriation to be used to fund a portion of the marae renovation projects outlined in this briefing, with the remainder funded by PGF funds.

## Purpose

---

1. In May 2020 Cabinet approved a package of PGF funding for immediate worker redeployment [CAB-20-MIN-0197]. This package is to provide immediate support for the redeployment of displaced workers, with an allocation for fencing of waterways and the renovation of town halls, war memorials, Marae and Pasifika churches. These projects are funded to maximise employment opportunities for workers impacted by COVID-19 by commencing within two months of approval and requiring no further consenting. Proposals must also demonstrate the facility is important to and used by a particular community.
2. The PDU has received a significant volume of applications for worker redeployment projects alongside other COVID-19 response investments. This is the fifth tranche of marae worker redeployment projects to be provided to Ministers.
3. If all recommended projects in this briefing are approved the total funding in marae renovations will total \$<sup>Commercial Information</sup>, towards <sup>Commercial</sup> number of marae as outlined in **Annex Fourteen**.
4. The PDU will be responsible for contracting and monitoring these projects. With such a large number of marae projects being funded the PDU will implement a programme management approach to:
  - a. Enable a consistent approach to the contracting and management of both the individual and clusters of marae
  - b. Provide more effective and efficient procurement and project management, including using PDU processes and systems
  - c. Enhance monitoring and reporting
  - d. Manage contingencies and potential cost over-runs.
5. Most renovation works consist of upgrading the main buildings in the marae complex, the wharenui (meeting house), the wharekai (dining rooms) and the ablutions. General works include recladding, exterior and interior painting, insulation, roofing, flooring, rewiring, lighting repairs, landscaping and access/driveway improvements.
6. The range of professions to complete the marae renovations typically include site managers, carpenters, electricians, painters, plumbers, labourers, project manager/co-ordinator, project administrator. The projects vary in length from a month to over a year, and have variety of part and full-time contractors depending on the length of the project and the type of project work.
7. The job numbers provided by the applicants and in the quotations are to be confirmed during contracting and will be reported both during and at the completion of each project.

### **Conditions precedent for Worker Redeployment contracts**

8. The approvals for worker redeployment projects will be subject to the usual PDU contracting provisions including:
  - a. Procurement to the satisfaction of PDU (this includes subcontractors);
  - b. Confirmation of final costs
  - c. Satisfactory due diligence;
  - d. Satisfactory financial analysis; and
  - e. Advice from Te Puni Kokiri.

9. A provision of up to 10% contingency of the total project costs, already included in the recommended funding above, if deemed necessary by the PDU to complete the project.
10. Where necessary the PDU will apply further conditions of funding, such as confirmation that building consents are not required or have been obtained for the proposed renovation work.
