Accident Compensation Amendment Regulations

Portfolio ACC

On 11 March 2021, the Cabinet Legislation Committee:

- **noted** that on 3 August 2020, the Cabinet Economic Development Committee agreed:
 - 1.1 to increase rates in the Accident Compensation (Liability to Pay or Contribute to Cost of Treatment) Regulations 2003 (the Cost of Treatment Regulations) by:
 - 1.1.1 2.05 per cent for Counsellors, Dentists, Specialists, Specified Treatment Providers, Nurses, Medical Practitioners, Combined services (Nurse/Medical Practitioner) and Audiologists (service-based codes only);
 - 1.1.2 1.72 per cent for Radiologists and Hyperbaric Oxygen Treatment;
 - 1.2 agreed to remove provisions in the Cost of Treatment Regulations that require funding deductions for dental treatment, where a claimant has received previous treatment on the same tooth for a non-accident related purpose;
 - 1.3 agreed to separate 'Specified Treatment Providers' in the Cost of Treatment Regulations, to provide for separate payment rates for Acupuncturists, Chiropractors, Occupational Therapists, Osteopaths, Physiotherapists, Podiatrists, and Speech Therapists;

- noted that the Accident Compensation (Liability to Pay or Contribute to the Cost of Treatment) Amendment Regulations 2021 and the Accident Compensation (Apportioning Entitlements for Hearing Loss) Amendment Regulations 2021 give effect to the decisions referred to in paragraphs 1.1 and 1.2 above;
- noted that during the drafting process, it became clear that it is appropriate that the decision set out in paragraph 1.3 above, to separate 'specified treatment providers' in the regulations to provide for separate payment rates for different occupations, be implemented after separate payment rates are formulated in future reviews;
- 4 **authorised** the submission to the Executive Council of the:
 - 4.1 Accident Compensation (Liability to Pay or Contribute to the Cost of Treatment) Amendment Regulations 2021 [PCO 23167/7.0];

- 4.2 Accident Compensation (Apportioning Entitlements for Hearing Loss) Amendment Regulations 2021 [PCO 23168/7.0];
- 5 **noted** that the Amendment Regulations come into force on 1 May 2021;
- **noted** that section 324(2) of the Accident Compensation Act 2001 requires that the responsible Minister receive a recommendation from ACC and that the responsible Minister be satisfied that consultation with the persons and organisations the Minister considers appropriate has occurred before recommending the making of an Order in Council under section 324;
- 7 **noted** the advice of the Minister for ACC that the requirements of section 324(2) have been met
