Minor and technical change to Regulations

Purpose

This note asks you to direct the Ministry of Business, Innovation and Employment (MBIE) to issue drafting instructions to Parliamentary Counsel Office (PCO) to extend the expiry date of the regulations suspending the ability of persons offshore to apply for a temporary entry-class visa by a further three months from 7 May 2021.

PCO has advised that, as this change is minor and technical, your agreement to those drafting instructions is sufficient for PCO to draft the required amendment regulation, and a formal Cabinet decision is not required.

We note that:

- two further technical changes to these regulations may be agreed to by Cabinet through a separate paper from the Minister for COVID-19 Response seeking decisions on quarantinefree travel settings, and
- a draft paper seeking Cabinet's approval of the amendment regulations will be provided to your office for ministerial consultation on Thursday 4 March 2021.

Recommended action

The Ministry of Business, Innovation and Employment recommends that you:

a **Note** that the *Immigration (Visa, Entry Permission, and Related Matters) Amendment* (COVID-19 – Visa Applications and Fees) Regulations (No.3) 2020, which have suspended the ability of persons offshore to apply for temporary entry-class visas, expire on 7 May 2021

We seek your approval to issue drafting instructions to PCO

- 1. The *Immigration (COVID-19 Response) Amendment Act 2020*, which gave the Minister of Immigration a number of powers to address the impacts of COVID-19, came into force on 16 May 2020. One of those powers suspends the ability of persons outside of New Zealand from applying for a temporary entry class visa for a period of three months. It must be exercised through Order in Council (Regulations).
- In July 2020, Cabinet agreed for the first time to suspend the ability of most persons outside of New Zealand from applying for a temporary entry class visa for a period of three months [CBC-20-MIN-0069, LEG-20-MIN-0108]. Cabinet approved the *Immigration (Visa, Entry Permission, and Related Matters) Amendment (COVID-19 – Visa Applications and Fees) Regulations 2020*, which implemented that decision, and which came into effect on 10 August 2020.
- 3. Cabinet has approved two further extensions to those Regulations in the interim. The current term will expire on 7 May 2021, just over a week before it is anticipated that the proposed *Immigration (COVID-19 Response) Amendment Act 2021* will come into effect. That Act is intended to, among other things, extend the suspension period to up to six months at a time.
- 4. The two extensions to date have been effected through Cabinet papers which simultaneously sought agreement to the policy (further extending the suspension period) and the amendment regulations effecting it (most recently the *Immigration (Visa, Entry Permission, and Related Matters) Amendment (COVID-19 Visa Applications and Fees) Regulations (No. 3) 2020*) [CAB-20-MIN-0528].
- 5. Similarly, PCO is prepared to draft this change prior to formal Cabinet agreement, but has requested that we provide a document indicating your agreement to the extension proceeding. This will meet standard requirements to authorise minor and technical changes. We therefore recommend that you direct officials to issue drafting instructions to PCO to extend the expiry date of the Amendment Regulations by a further three months from 7 May 2021.

A paper seeking decisions on quarantine-free travel settings may further amend the regulations

- 6. Your colleague, the Minister for COVID-19 Response, is currently developing a paper aimed at seeking agreement on settings and implementation details for quarantine-free travel zones. If that paper proceeds, it will propose two additional regulation changes, to:
 - a. ensure that once a quarantine-free travel zone is in place, third country nationals in that zone can continue to make applications for temporary entry class visas, regardless of whether quarantine-free travel is in effect or not; and
 - b. amend the references to Safe Travel Zone to Quarantine-free travel zone (in line with preferences expressed by the Ministry of Health, which considers such travel to be low –risk rather than safe).
- 7. Those changes, if agreed, will be incorporated into the Amendment Regulations to be considered by Cabinet towards the end of this month.
