## Construction Sector Accord 2020: Progress and Next Steps

Portfolios Housing / Building and Construction

On 14 April 2021, the Cabinet Economic Development Committee (DEV):

- 1 **noted** that on 4 December 2019, DEV:
  - approved the Construction Sector Transformation Plan (the Transformation Plan) and endorsed its implementation by government agencies and industry;
  - invited the Minister for Building and Construction to report back to DEV on progress on the delivery of the Transformation Plan by the end of 2020;

- 2 **noted** that Budget 2020 approved funding for the Transformation Plan until June 2022 [CAB-20-MIN-0219];
- noted the progress made on delivering the Transformation Plan in 2020, as outlined in the paper under DEV-21-SUB-0084;
- 4 **invited** the Minister of Housing and the Minister for Building and Construction to report back to DEV in early 2022 on the progress made during 2021.
