Fair Trading Amendment Bill: Supplementary Order Paper

Portfolio Commerce and Consumer Affairs

On 11 March 2021, the Cabinet Legislation Committee:

- noted that the Fair Trading Amendment Bill amends the Fair Trading Act 1986 to introduce new protections against unfair commercial practices, including a prohibition on unconscionable conduct and protections against unfair contract terms in small trade contracts (where the contracts are worth under \$250,000 per annum);
- noted that the Minister of Commerce and Consumer Affairs Confidential advice to Government
- noted that on 12 August 2020, the Economic Development, Science and Innovation Committee discharged the Fair Trading Amendment Bill without a report, and returned the Bill to the House for second reading as introduced;
- 4 **noted** that the Minister of Commerce and Consumer Affairs intends to make the following changes to the Bill at the Committee of the whole House stage:
 - 4.1. simplifying the definition of 'small trade contract' by removing the concept of 'related parties', with the effect that contracts between related parties such as a parent and subsidiary company will not count towards the \$250,000 annual value threshold to come under the unfair contract terms protections;
 - 4.2. allowing the application of the unfair contract terms provisions to business insurance contracts to be delayed until changes arising from the Government's review of insurance contract law are developed and passed; and
 - 4.3. technical clarifications to improve drafting;
- **authorised** the release of the Supplementary Order Paper to the Fair Trading Amendment Bill [PCO 21917-1/6.0] which gives effect to the amendments in paragraph 4;
- authorised the Minister of Commerce and Consumer Affairs to make minor or technical changes to the Supplementary Order Paper prior to lodgement;

agreed that the Supplementary Order Paper be released by 16 March 2021.
