COVID-19 Public Health Response (Validation of Managed Isolation and Quarantine Charges) Amendment Bill: Approval for Introduction

Portfolio COVID-19 Response

On 13 May 2021, the Cabinet Legislation Committee:

- noted that on 19 April 2021, Cabinet agreed to introduce legislation to retrospectively validate how Australian citizen and permanent residents have been charged for MIQ and amend the COVID-19 Public Health Response (Managed Isolation and Quarantine Charges) Regulations 2020 to ensure that they reflect Cabinet's policy intent [CAB-21-MIN-0140];
- 2 **noted** that the COVID-19 Public Health Response (Validation of Managed Isolation and Quarantine Charges) Amendment Bill gives effect to these decisions;
- approved for introduction the COVID-19 Public Health Response (Validation of Managed Isolation and Quarantine Charges) Amendment Bill [PCO 23757/1.9], subject to the final approval of the government caucus and sufficient support in the House of Representatives;
- 4 agreed that the Bill be introduced and enacted on 20 May 2021 as part of the Budget.
