On 20 May 2021, the Cabinet Legislation Committee:

Confidential advice to Government 1 2 noted that the Bill will strengthen and clarify the retention money regime in the Construction Contracts Act 2002; 3 approved the Construction Contracts (Retention Money) Amendment Bill [PCO 22624/10.0] for introduction, subject to the final approval of the government caucus and sufficient support in the House of Representatives; 4 agreed that the Construction Contracts (Retention Money) Amendment Bill be introduced in May 2021; 5 agreed that the government propose that the Bill be: 5.1 referred to the Economic Development, Science and Innovation for consideration; Confidential advice to Government 5.2 Rebecca Davies **Committee Secretary**
