PGF funding is required to allow us to purchase equipment which will enable us to increase our productivity and meet the customer demands in a more-timely manner. The equipment will also provide us with greater opportunities to successfully tender for more commercial as we will be able to show that we have the equipment to meet any requirements in-house.

There are a number of areas of our business where our efficiencies could be increased with the inclusion of more automated machinery.

The two pieces of equipment we require are:

1. CNC Twin Saw

[The CNC Twin saw will automate a current manual process which is slowing down our productivity. We currently manually measure and cut our aluminium. This is a crucial part of our fabrication process to have accurate and human error regularly impedes us.

2. CNC Router

Commercial Information

[The CNC router is computerised and precise. It will increase productivity and efficiency at this stage of the fabrication process. It will eliminate simple human error and allow production to follow on seamlessly from this point. Currently in our factory process when machining in completed incorrectly we have a 10 working day lead time to receive replacement metal.

General

The terms and conditions are non-negotiable and do not require a response. Reliance by Provincial Development Unit

The Provincial Development Unit may rely upon all statements made by any applicant in an application and in correspondence or negotiations with the Provincial Development Unit or its representatives. If an application is approved for funding, any such statements may be included in the contract.

- Clear evidence of public benefits (i.e. benefits other than increased profitability for the applicant)
- Are in a Government priority region or sector

Additionality

- Project is not already underway, does not involve maintenance of core infrastructure or assets (except for rail and transport resilience initiatives), and does not cover activities the applicant is already funded for (funding could be considered to increase the scale of existing projects or re-start stalled projects)
- Demonstrated benefit of central Government investment or support
- Detail of any supporting third party funding (and any funding sought unsuccessfully)
- Acts as a catalyst to unlock a region's productivity potential
- Demonstrated links to other tiers of the Fund and related projects, to maximise value of Government investment

Connected to regional stakeholders and frameworks

- Evidence of relevant regional and local support, either through existing regional development mechanisms, or through another relevant body such as a council, iwi or other representative group (or reasons for any lack of local support)
- Has been raised and discussed with the region's economic development governance group
- Alignment with, or support for the outcomes of, any relevant regional development plan, Māori development strategy or similar document (whether regional or national)
- Demonstrated improvement in regional connectedness (within and between regions)
- · Leverage credible local and community input, funding, commercial and non-commercial partners
- Utilise existing local, regional or iwi/Māori governance mechanisms

Governance, risk management and project execution

- Evidence of robust project governance, risk identification/management and decision-making systems and an implementation plan appropriate to the size, scale and nature of the project
- Future ownership options for capital projects, including responsibility for maintenance, further development, and other relevant matters
- · Benefits and risks clearly identified and quantified, depending on the scale of the initiative
- Evidence of potential exit gates and stop/go points, and a clear exit strategy
- Clearly identifies whole of life costs (capital and operating)
- Dependencies with other related projects are identified
- Evidence of sustainability after conclusion of PGF funding
- Adequacy of asset management capability (for capital projects)
- Compliance with international obligations (where relevant)
