Building for Climate Change Programme: Funding

Portfolio Building and Construction

On 23 June 2021, the Cabinet Economic Development Committee:

- noted that the Building for Climate Change Programme (the Programme) intends to significantly reduce the sector's carbon footprint and support transition to a sustainable, climate-resilient and low-emissions economy;
- 2 **noted** that the Minister for Building and Construction was not invited to submit a Budget bid for the Building for Climate Change Programme, and instead was encouraged to identify opportunities to reprioritise existing baselines to fund the Programme;
- agreed to fund the next phase of work for the Programme in the 2021/22 and 2022/23 financial years through a repurposing of resources in the Vote Building and Construction from the Weathertight Services appropriation;
- **approved** an in-principle expense transfer of up to the following maximum amount of operating expenditure from 2020/21 to 2021/22 and 2022/23:
