# Migrant Settlement and Integration Services for 2021/22: Funding from the Immigration Levy

Portfolio Immigration

On 23 June 2021, the Cabinet Economic Development Committee:

#### **Background**

- 1 **noted** that in 2015, Cabinet:
  - 1.1 approved \$6.990 million of Immigration Levy revenue annually to support settlement services across government agencies (that had previously been funded from the Migrant Levy);
  - 1.2 agreed that the 2016/17 allocations remain the same as 2015/16;
  - 1.3 directed officials to report back to the Minister of Immigration on the design of a new funding allocation process to fully implement the New Zealand Migrant Settlement and Integration Strategy (the Strategy) from 2017/18;

- 2 **noted** that in 2017, Cabinet:
  - agreed that the Immigration Levy settlement funding allocations would be for a fouryear period (specifically for the period of 2017/18 to 2020/21);
  - 2.2 authorised the Minister of Finance, the Minister of Immigration and the relevant Vote Minister to make the final decisions within the four-year period on any adjustment to the allocations within the overall \$6.990 million annual funding;

noted that a Cabinet decision is now required to allocate funding from the Immigration Levy to support settlement services for 2021/22;

#### **Immigration Levy funding allocations for 2021/22**

**agreed** to the cross-agency allocations of the \$4.798 million Immigration Levy funding for 2021/22 for the following mix of settlement services that support the Strategy:

- **noted** that given the impact of COVID-19 on the Immigration Levy revenue stream, the allocation of this funding will further increase the deficit in the Immigration Levy hypothecation account;
- 6 **noted** that a review of the immigration funding model is underway, which will consider options for the future allocation of Immigration Levy funding and Confidential advice to Government
- 7 Confidential advice to Government
- 8 **noted** that Immigration Levy funding allocations for the following settlement services will not be continued from 2021/22:
  - 8.1 ESOL in schools (Vote Education);
  - 8.2 national level support for organisations that facilitate migrant participation in host communities (Vote Labour Market);
