Major Events Management Order 2021

Portfolio Economic and Regional Development

On 28 October 2021, the Cabinet Legislation Committee:

- noted that the Minister for Economic and Regional Development recommends that the Governor General, by Order in Council, declare the ICC Women's Cricket World Cup 2022 to be a 'major event' and certain emblems and words related to be 'major event emblems and words' under the Major Events Management Act 2007;
- 2 **noted** that before recommending the making of an Order in Council, the Minister for Economic and Regional Development consulted with the Minister of Commerce and Consumer Affairs and Minister for Sport and Recreation and other persons as required under sections 7 and 8 of the Major Events Management Act 2007;
- authorised submission to the Executive Council of the Major Events Management (ICC Women's Cricket World Cup 2022) Order 2021 [PCO 23727/7.0];
- 4 **noted** that the Major Events Management (ICC Women's Cricket World Cup 2022) Order 2021 will come into force on 3 December 2021 and will expire on 4 May 2022.
