# Draft Advanced Manufacturing Industry Transformation Plan: Release for Public Consultation

Portfolio Economic and Regional Development

On 13 April 2022, the Cabinet Economic Development Committee (DEV):

- 1 **noted** that on 24 June 2020, as part of the government's refreshed Industry Strategy, DEV agreed to create an Industry Transformation Plan for the advanced manufacturing sector [DEV-20-MIN-0110];
- 2 **noted** that the Advanced Manufacturing Industry Transformation Plan is an opportunity for business, unions, government, Māori and wider stakeholders to co-create and co-own a plan to accelerate the growth and transformation of Aotearoa New Zealand's advanced manufacturing sector;
- 3 **noted** that a driving principle of Industry Transformation Plans is partnership, and that representatives from business, unions, government, Māori and wider stakeholders have participated in a Steering Group and four Working Groups to prepare a Draft Advanced Manufacturing Industry Transformation Plan (attached as Appendix One to the paper under DEV-22-SUB-0084);
- 4 **noted** that the priorities and actions in the Draft Advanced Manufacturing Industry Transformation Plan align with the government's economic strategy of a high wage, low emissions, productive, sustainable and inclusive economy as the government accelerates economic recovery and builds back better;
- 5 **noted** that the priorities identified in the Draft Advanced Manufacturing Industry Transformation Plan include:
  - 5.1 increasing investment in advanced technologies and processes to lift productivity and wages;
  - 5.2 making innovation, R&D and science work for manufacturing;
  - 5.3 attracting and developing a diverse high-skilled and high-wage workforce;
  - 5.4 creating a leading circular net-zero emissions sector;
  - 5.5 enhancing global connectivity and opportunities;

- 6 **noted** that implementation of the final action plan will require funding and policy support from government, as well as active and ongoing commitment from business, unions and wider stakeholders;
- 7 **agreed** to the release of the Draft Advanced Manufacturing Industry Transformation Plan for public consultation, subject to any minor or technical amendments that may be required;
- 8 **noted** that feedback from public consultations and the outcomes of Budget 2022 will be reflected in the Final Industry Transformation Plan that will be brought to Cabinet in August 2022 before its public release in September 2022.
