Motor Vehicle Sales Amendment Regulations 2022 and Motor Vehicle Sales (Motor Vehicle Disputes Tribunals Funding Levy) Amendment Regulations 2022

Portfolio Commerce and Consumer Affairs

On 9 June 2022, the Cabinet Legislation Committee:

- noted that in April 2022, the Cabinet Economic Development Committee agreed to amend fees in the Motor Vehicle Sales Regulations 2003 and the levy in the Motor Vehicle Sales (Motor Vehicle Disputes Tribunals Funding Levy) Regulations 2003 [DEV-22- MIN-0070];
- 2 noted that minor amendments have been made to other fee amounts (that were not part of the fees and levy review) within the Motor Vehicle Sales Regulations 2003 and Motor Vehicle Sales (Motor Vehicle Disputes Tribunals Funding Levy) Regulations 2003, to express amounts as GST exclusive, consistent with other regulations that prescribe fees and levies;
- noted that the Motor Vehicle Sales Amendment Regulations 2022 and the Motor Vehicle Sales (Motor Vehicle Disputes Tribunals Funding Levy) Amendment Regulations 2022 will give effect to the decision referred to in paragraph 1 above;
- 4 **authorised** the submission to the Executive Council of the:
 - 4.1 Motor Vehicle Sales Amendment Regulations 2022 [PCO 24640/4.0];
 - 4.2 Motor Vehicle Sales (Motor Vehicle Disputes Tribunals Funding Levy) Amendment Regulations 2022 [PCO 24641/4.0];
- 5 **noted** that the Motor Vehicle Sales Amendment Regulations 2022 and the Motor Vehicle Sales (Motor Vehicle Disputes Tribunals Funding Levy) Amendment Regulations 2022 come into force on 1 August 2022.
