This is problematic: e.g. defining a site with toilet facilities is problematic in terms of distance from ones vehicle. A site could be 2km long and have a toilet at one end. Usage by campers 2km away is likely to be low, especially at night. Also it doesn't take the non-self-contained vehicles out of the environment and they may still choose not to camp near a toilet, resulting in no improvement to the present situation.

Any distance rules are bound to be problematic to apply and enforce. They potentially create another avenue for creative users to navigate their way around. They add extra administrative burden to enforcement.

What would be an appropriate penalty?

 - Should fines be similar to those for not holding a valid Warrant of Fitness for a motor vehicle?

Non-compliant vehicles should be confiscated after 2 warnings i.e. at the 3rd rule-breaking. Therefore a recording system will be needed to record when warnings have been given. Fines should be collected in the case of rental vehicles by the rental agency. Fines for privately owned vehicles should be collected by the local council

 Is the current standard fit for purpose? When answering this question you may like to think about: 5.2 Should there be a requirement that self-contained vehicles have fixed toilets? Should there be specific reference to the types of vehicles that can be self-contained? It is ridiculous that one can get CSC for a station wagon. Toilets should be fixed and in an enclosed (vented) place that allows an adult user to stand up while using the toilet. Defining the types of vehicles is problematic - far better to have a specification as we have outlined since by definition, for example, a station wagon or sleeper van would never get CSC.

What transition arrangements should be in place?

Allow 12 months to upgrade or dispose of private vehicles. Rental vehicles should be given 6 months.

Currently certified self-contained vehicles should not be exempt since some may not actually comply with new standards.

How could Government ensure vulnerable groups are not further disadvantaged?

6.2 • Could Government make homelessness exempt from any new regulatory system? What might this look like?

Camping wardens/inspectors must be trained to recognise the difference between the homeless and the deliberate rule-breakers. The intention must not be to punish the unfortunate but those who are intentionally evading regulations

7.1 Is there anything else on the proposed changes or discussion document you would like to mention?

We understand that some rental companies charge the renter a fee when the vehicle is returned and the toilet is found to have been used. This policy is a disincentive to use the toilet and as such should not be allowed. Since the company must in all cases ensure the toilet is empty and has appropriate chemicals in it for the next user - the charge for doing this should be incorporated into the hire fee.
