### Updating the Hearing Assessment Regulations: Approval to Consult

Portfolio ACC

On 27 July 2022, the Cabinet Social Wellbeing Committee (SWC):

- 1 **noted** that consultation requirements under section 323 of the Accident Compensation Act 2001 must be met before recommending any changes to the Accident Insurance (Occupational Hearing Assessment Procedures) Regulations 1999;
- 2 **agreed** to release the discussion document titled *Proposed amendments to the Accident Insurance (Occupational Hearing Assessment Procedures) Regulations 1999*, attached under SWC-22-SUB-0130, for public consultation;
- 3 **noted** that consultation is scheduled to be undertaken over four weeks;
- 4 **invited** the Minister for ACC to report back to SWC following consultation with final recommendations, including final costings and any impact on levy rates and Budget appropriation;
- 5 **noted** that there may be other technical amendments to the Regulations which will be included in the final recommendations.
