Space Policy Review

Portfolio Economic and Regional Development

On 24 August 2022, the Cabinet Economic Development Committee:

- **noted** that the consultation document *New Zealand Space Policy Review Consultation* (the consultation document), attached to the paper under DEV-22-SUB-0194, seeks feedback on a range of space values and policy objectives which inform New Zealand's space policies;
- agreed to the release of the consultation document for an eight-week consultation period, subject to any minor, editorial or technical changes that may be authorised by the Minister for Economic and Regional Development before its release;
- **noted** that the feedback from the consultation will be used to inform the development of a National Space Policy;
- 4 **noted** that the space policy review is a separate workstream to the statutory review of the Outer Space and High-altitude Activities Act 2017;
- 5 **noted** that the objectives in the space policy review complement the separate draft Aerospace Strategy [DEV-22-SUB-0200], which focuses on actions through to 2030 for the government and aerospace (advanced aviation and space) sector to grow.
