Regulations under the Incorporated Societies Act 2022: Release of Discussion Document

Portfolio Commerce and Consumer Affairs

On 29 September 2022, the Cabinet Government Administration and Expenditure Review Committee:

- **noted** that the regulation-making provisions of the Incorporated Societies Act 2022 have entered into force, and most of the rest of the statute will enter into force in early October 2023;
- 2 **noted** that, for the Incorporated Societies Act 2022 to function as intended, it is critical that the Governor-General make regulations under the regulation-making powers in the statute;
- 3 **noted** that the Minister of Commerce and Consumer Affairs (the Minister) intends to take a two-step approach to public consultation on the regulations, with a discussion document this year and an exposure draft of the regulations in early 2023;
- 4 **noted** that officials have prepared a discussion document *Consultation on regulations for the Incorporated Societies Acts 2022* seeking stakeholder feedback on what regulations should be made and what they should prescribe;
- 5 **agreed** to the release of the discussion document;
- 6 **authorised** the Minister of Commerce and Consumer Affairs:
 - 6.1 to determine the precise dates for the consultation period;
 - 6.2 once the consultation period has closed, to issue drafting instructions to the Parliamentary Counsel Office for an exposure draft of the regulations;
- 7 **invited** the Minister of Commerce and Consumers Affairs to report back to Cabinet with the exposure draft of the regulations.
