Onshore Fuel Stockholding

Firstgas Group welcomes the opportunity to comment on the Ministry of Business, Innovation and Employment's (MBIE) consultation paper *"Onshore Fuel Stockholding"* released in January 2022. MBIE proposes that obligated parties would have to ensure target levels of fuels are held in New Zealand and report fuel stockholdings to MBIE.

We are concerned that the proposal inadvertently places obligations on our Rockgas business. The definitions used by the proposal mean that:

- Many parties that MBIE intended to not have stockholding obligations would have obligations
- Some parties that MBIE intended to have stockholding obligations would have none.

Accordingly, we recommend MBIE amend its proposal to accurately define the intended parties.

MBIE's intentions versus application of proposed definition

Based on the consultation paper, we understand MBIE's intention was to only obligate a few parties from the top of the supply chains for diesel, petrol, and jet fuel (and the biofuel equivalents for each). On page 33 of the consultation paper, MBIE states that "fuel wholesale suppliers, as defined in the *Fuel Industry Act 2020*" (Act) would have obligations.

That Act defines a wholesale supplier as "a person that sells and supplies engine fuel, as the whole or part of its business, to persons other than end users." It uses a definition of engine fuel that is very broad: "any gaseous or liquid fuel that can be used as a fuel for engines…".

Engine fuels could include liquid petroleum gas (LPG), compressed natural gas (CNG) and natural gas. Even lemon juice *can* power an engine. Our Rockgas business does sell some LPG to non-end users (principally, our franchisees). As such, we are concerned that we meet the definition of a "wholesale supplier" and would be given unintended obligations. Many other businesses would also be unintentionally included.

Relying on the definition of wholesale supplier means that parties that sell only to end-users are excluded from any obligation. For example, a hypothetical petrol retailer that imports 50% of New Zealand's petrol needs but sells only to end-users would have no obligation. This is clearly contrary to the intent of the proposal.
