New Zealand has previously committed to the peaceful use of space, opposition to war crimes, and to oppose the proliferation and use of weapons of mass destruction.

Companies like Rocket Lab that openly collaborate with the American military are operating directly at odds with those commitments. The American military exists solely to commit war crimes against innocent human beings, has been involved in several outright illegal wars of aggression in this century alone, and continues to illegally occupy peaceful nations like Syria to support ISIS, Al Nusra Front, and other terrorist groups there.

The American military has previously used space technology to provide targetting intelligence for the use of weapons of mass destruction, as even Foreign Policy magazine has admitted (<a href="https://foreignpolicy.com/2013/08/26/exclusive-cia-files-prove-america-helped-saddam-as-hegassed-iran/">https://foreignpolicy.com/2013/08/26/exclusive-cia-files-prove-america-helped-saddam-as-hegassed-iran/</a>). Any space launches conducted for Americans, whether for communications or reconnaissance purposes, will be used for similar purposes in future. Continued collaboration with the US is a crime against humanity and a violation of our international treaty obligations for disarmament and the peaceful uses of space.

The use of New Zealand soil to launch military payloads for the US rogue state is making Mahia Peninsula a legitimate military target for any country attacked by America, as they are wont to do every year or two. This is utterly unacceptable.
