We also will operate MethaneSAT which is a prime example of partnering with global agencies to further understand the impacts of climate change. So, I believe it would be a matter of weighing these things up.

It's important to consider the ramifications of disallowing certain payloads to launch from NZ soil based on a definition of what New Zealander's believe benefit them. When it comes to the space sector in New Zealand, and specifically as someone who works for Rocket Lab and loves it, if we were to face significantly more friction for what we can and can't launch from New Zealand it is likely our business would suffer. Rocket Lab employs hundreds of people in Aotearoa and for me personally I am very happy to see so much amazing innovation go on in my home country. While I of course believe in furthering New Zealand's national interests, it's important to consider the potential side effects of restricting access to space from our land. The policy should be carefully constructed to allow for launch activities to go ahead in New Zealand, fostering innovation and a growing, inspired workforce, while also maintaining secure and safe use of space technology.
