Growing an innovative and inclusive space sector is of particular importance to me as a woman working in the space sector, and more generally as a woman working in a STEM role.

I am a member of the Women in Space Aotearoa New Zealand (WISANZ) network which was launched in 2021 to expand opportunities for women and gender minorities within the New Zealand space sector. We aim to grow representation in the sector through outreach programmes with high-school and tertiary students, encourage more women to join the sector, and support those already in the sector through networking, mentoring and other similar events.

New Zealand is already at the forefront of technology and achievements within the space sector, with growth of companies such as Rocket Lab, Dawn Aerospace, Kea Aerospace and a number of others. With further innovation, New Zealand has the opportunity to push the boundaries on what is possible, and create meaningful improvements for day-to-day lives of all Kiwi's. But diversity, equity and inclusivity within the sector is key to achieving meaningful innovation – diversity of backgrounds, thoughts. experiences, knowledge and perspectives all help to bring different ideas. This also applies to cultural minorities within the sector such as Māori and Pasifika.

Promotion of awareness and education around the NZ space sector by the Government would bring more investment and make opportunities more widely known. This could be achieved through investment in a "New Zealand mission" which the public could get behind, and have the advantage of addressing multiple policy objectives noted above within a single mission.
