At the Disarmament and Security Centre we are interested in ensuring that New Zealand's interests and relationships in space are of a peaceful nature and not contributing to the weaponization of space. We would like to ensure that all of New Zealand's activities in space are clearly in line with our international legal obligations including such Treaties as the Treaty on the Prohibition of Nuclear Weapons in which New Zealand has agreed not to "assist, encourage or induce, in any way, anyone to engage in activities prohibited... under this Treaty". The feedback I have set out below comes from discussions within our organisation and a number of colleagues across the country.

As above, our kaitiakitanga of our space activities must ensure that our activities are of a peaceful nature and not contributing to the weaponisation of outer space. We must ensure that all payloads are assessed alongside our international legal obligations (and these be explicitly stated and understood by officials assessing payloads) to ensure that we are not inadvertently contributing to activities which are prohibited under NZ domestic and international law. There is currently tension between the main space actors – China, Russia and the US to gain dominance in space and New Zealand must be careful not to exacerbate these tensions through launching specific payloads that may contribute to one nation's dominance over another.

As above – at the Disarmament and Security Centre, we are concerned about some payloads that have been launched for overseas military clients. We have not been satisfied with the information released by MBIE, relevant Ministers and the Government about assessment processes for these specific payloads as they have lacked transparency about how the payload has been assessed, and by whom (individually and which agencies have been involved). They have also lacked detail on the possible dual-use nature of the various payloads which leaves the public concerned that NZ may be inadvertently launching payloads that may eventually be operational parts of other nations' nuclear weapons programmes – such as command and control, geo-positioning etc.

While the NZ space industry is often discussed as helping to advance various communications, environmental etc. monitoring, it appears that in reality a large number (if not most) of the payloads being launched are for overseas military clients.

Are there any other policy objectives that you think would help the New Zealand government to promote the responsible uses of space internationally?

As of 2022, the peaceful and equitable use of space is being threatened by growing military competition among major powers (China, Russia, United States) and that smaller states with space launch capabilities such as New Zealand are being drawn in. Ensuring the peaceful use of space requires working proactively to prevent the weaponisation of this global commons. This is of paramount importance and could be better reflected in these policy objectives outlined in the consultation document. MBIE should reflect New Zealand's strong commitment to not only "safe and secure" access to and use of space, but to work for "a space environment that is sustainable, peaceful, and free from conflict," as MFAT stated in its May 2021 submission to a study by the United Nations Secretary-General.

Aotearoa NZ needs to be explicit about its commitment to not contributing to the weaponsiation of space in our regulations and policies guiding space practices. We need to be explicit as to what legislation applies – international Treaties and domestic legislation and ensure both clients and officials assessing payloads are fully aware of these laws. When assessing the payloads, officials must not only take into account the black and white letter of the law, but also the spirit and values of the legislation - such as the NZ Nuclear Free Zone Act and the Treaty on the Prohibition of Nuclear Weapons.
