Description of coverage currently proposed:


The initiating union applied for approval to initiate bargaining for a fair pay agreement in the interurban and rural bus transport industry. Included in the application is a list of ANZSIC and ANZSCO occupational codes.

The initiating union relied on the 10% representation test.

The Ministry of Business Innovation and Employment (MBIE) is assessing the proposed coverage to ensure compliance with the Fair Pay Agreements Act 2022.
