Plant Variety Rights Regulations 2022 and Plant Variety Rights Act 2022 Commencement Order 2022

Portfolio Commerce and Consumer Affairs

On 15 December 2022, the Cabinet Legislation Committee:

- 1 noted that on 24 November 2021, the Cabinet Economic Development Committee (DEV) agreed that the regulations to support the new Plant Variety Rights Act 2022 be based on the Patents Regulations 2014 where it makes sense to do so, with specific adjustments to accommodate the unique nature of plant variety rights [DEV-21-MIN-0246];
- 2 **noted** that on 16 November 2022, DEV approved changes to the Plant Variety Rights fees structure and levels [DEV-22-MIN-0266];
- 3 **noted** that the Plant Variety Rights Regulations 2022 give effect to the decisions referred to in paragraphs 1 and 2;
- 4 **authorised** the submission to the Executive Council of the Plant Variety Rights Regulations 2022 [PCO 24320];
- 5 **noted** that the Plant Variety Rights Regulations 2022 come into force on 24 January 2023;
- 6 **noted** that some provisions of the Plant Variety Rights Act 2022 came into force the day after Royal assent, and under section 2(2) of the Act the remaining provisions must be brought into force by Order in Council within two years of Royal assent;
- 7 **noted** that subpart 3 of Part 5 of the Plant Variety Rights Act 2022 (under which the Māori Plant Varieties Committee starts considering certain PVR applications) cannot be brought into force within one year of Royal assent;
- 8 **noted** that the Plant Variety Rights Act 2022 Commencement Order 2022 bring the remaining provisions of the Plant Variety Rights Act 2022 (except subpart 3 of Part 5) into force on 24 January 2023;
- 9 authorised the submission to the Executive Council of the Plant Variety Rights Act 2022 Commencement Order 2022 [PCO 24866/5.0];

10 **noted** that the Plant Variety Rights Act 2022 Commencement Order 2022 comes into force on 24 January 2023.
