Release of the Advanced Manufacturing Industry Transformation Plan

Portfolio Economic and Regional Development

On 16 November 2022, the Cabinet Economic Development Committee (DEV):

Background

- noted that advanced manufacturing has been prioritised for an Industry Transformation Plan (ITP) due to the sector's scale and potential to significantly increase productivity, higher-skill higher-wage jobs, and a globally competitive low emissions sector [DEV-20-MIN-0110];
- **noted** that the Advanced Manufacturing ITP is an opportunity for business, unions, government, Māori, Pacific peoples and wider stakeholders to co-create and co-own a plan to accelerate the transformation and growth of Aotearoa New Zealand's advanced manufacturing sector;
- **noted** that a driving principle of ITPs is partnership, and that representatives from business, unions, government, Māori and wider stakeholders participated in a Steering Group and four Working Groups to prepare a draft Advanced Manufacturing ITP;
- 4 **noted** that:
 - 4.1 on 13 April 2022, DEV agreed to the release of the draft Advanced Manufacturing ITP for public consultation [DEV-22-MIN-0084];
 - 4.2 public consultation on the draft Advanced Manufacturing ITP was comprehensive, including 12 regional workshops, 13 factory site visits, 6 thematic workshops, 60 written submissions, hui Māori and dedicated Pacific peoples' engagement;

Final Advanced Manufacturing ITP

- 5 **noted** that the final Advanced Manufacturing ITP identifies the following priorities for transformation and growth:
 - 5.1 increasing investment in advanced technologies and processes to lift productivity and wages;
 - 5.2 developing and attracting a diverse high-skilled high-wage workforce;
 - 5.3 creating a leading circular net-zero emissions sector;
 - 5.4 improving understanding and perceptions of advanced manufacturing;

- 5.5 making innovation, R&D and science work for advanced manufacturing;
- 5.6 enhancing global connectivity and opportunities;
- 6 **noted** that overwhelming sector support was expressed during consultations for urgent action to implement Priority 1 (increasing investment in advanced technologies and processes to lift productivity and wages) and Priority 2 (developing and attracting a diverse high-skilled high-wage workforce) to achieve transformational change;
- noted that the Advanced Manufacturing ITP's Priority 1 (increasing investment in advanced technologies and processes to lift productivity and wages) is seen by business, unions and Māori as a pivotal intervention and pre-requisite to lift productivity, higher-skill higher-wage jobs, and the transition to circular net-zero advanced manufacturing;
- 8 **noted** that the Advanced Manufacturing ITP priorities and recommendations are ambitious and, if implemented, would support the government's strategy of a high wage, low emissions economy that provides economic security for all;
- 9 **noted** that the Advanced Manufacturing ITP was allocated a Budget 2022 contingency of \$30 million to enable the delivery of the first stages of certain ITP actions, and that officials will separately seek Ministerial agreement to drawdown those funds;
- noted that the most significant Advanced Manufacturing ITP recommendations will require more funding and policy support from government to achieve transformational change;

Next steps

- agreed to the release of the final *Advanced Manufacturing Industry Transformation Plan*, attached to the paper under DEV-22-SUB-0264, subject to any minor or technical amendments that may be required;
- **noted** that the Advanced Manufacturing ITP will be launched at an event hosted by sector partners in early 2023;
- invited the Minister for Economic and Regional Development to report back to DEV by August 2023 on the implementation of the Advanced Manufacturing ITP.
