I think the value definition of Partnership needs to be adjusted - Mana whenua and Te Tiriti o Waitangi should be guiding all of this work. A lived experience example: I have spoken with Kaumatua in Mahia who felt the local government (Wairoa Council) were dishonest and pressured them into agreeing to the Rocket Lab. The government and its entities need to do better. Using whakaaro Māori like kaitiakitanga is an example of the crown's continued neo-colonial actions and weaponising of Māori

knowledge systems. Please do better at listening to and being guided by Māori, all will benefit.

Innovation is less important than listening to the wisdom of the land and its people. All value definitions should be updated to better reflect commitment to eco friendly and environmentally healing priorities. Innovation and economic interests not important.
