### Additional Item: Strengthening National Direction for Renewable Electricity Generation and Electricity Transmission: Consultation Document

Portfolio Energy and Resources

On 27 March 2023, Cabinet:

- 1 **noted** that Cabinet agreed on 8 February 2023 to release the consultation document *Strengthening National Direction on Renewable Electricity Generation and Electricity Transmission* (the consultation document) and that the preferred option would include providing policy direction for Renewable Electricity Generation (REG) and Electricity Transmission (ET) projects in the coastal environment [CAB-23-MIN-0013.01];
- 2 **noted** Crown Law has subsequently advised that implementing the preferred option would require an amendment to the Coastal Policy Statement (NZCPS);
- 3 **noted** the Minister of Conservation is the decision-maker on the NZCPS and would need to consult on a proposed consenting pathway for the NPS-REG and NPS-ET that conflicted with the NZCPS, and that this consultation would likely be contentious;
- 4 **agreed** that the policy intent of ensuring an efficient consenting regime for REG and ET in all areas including the coastal environment remains;
- 5 **agreed** that the consultation document not include a targeted amendment to the NZCPS, but seek views on the extent that consenting in the coastal environment is an issue for developers and signal the intent to deal with these issues through the National Planning Framework;
- 6 **noted** that the proposed National Policy Statements will provide that REG and ET are prioritised in all other areas and will specifically deal with the key issues for developers of biodiversity, significant natural areas, and landscapes and amenity values;
- 7 **noted** the NPF to be developed under the Natural and Built Environments Act will include national direction on infrastructure that is also enabling of renewable energy and transmission;
- 8 **agreed** for the consultation document to seek feedback in respect of how onshore REG and ET in the coastal environment could better provide for the operation, maintenance, and upgrade of existing transmission activities in the coastal environment;

#### IN CONFIDENCE

- 9 **noted** the consultation document will signal that, in respect of offshore REG and ET, the government intends to consider the consenting regime separately and will look at appropriate consenting policies that would apply in both the exclusive economic zone and territorial sea;
- 10 **authorised** the Minister of Energy and Resources and the Minister for the Environment to make further detailed changes to the consultation document in keeping with the decisions in the minute under CAB-23-MIN-0104.
