Seeking Proposals for Additions to the List of Occupational Diseases under the Accident Compensation Act 2001: Approval to Consult

Portfolio ACC

On 29 March 2023, the Cabinet Social Wellbeing Committee (SWC):

- 1 **noted** that the 2020 Labour Party Manifesto made a commitment to consider the range of conditions ACC covers and take an evidence-based approach to updating the list of chronic illnesses caused through workplace exposure to harmful environments;
- 2 **noted** that there has not been an update to Schedule 2 of the Accident Compensation Act 2001, the list of occupational diseases, since 2008;
- agreed to the release of the public consultation document Seeking Proposals for Additions to the List of Occupational Diseases under the Accident Compensation Act 2001 (the consultation document), attached to the submission under SWC-23-SUB-0024;
- 4 **invited** the Minister for ACC to report back to SWC later in 2023 on the outcome of consultation and to seek approval to policy proposals;
- **authorised** the Minister for ACC to make minor amendments to the consultation document before release if required.
