Tourism Industry Transformation Plan: Environment Phase: Release of Draft Tourism Environment Action Plan

Portfolio Tourism

On 7 June 2023, the Cabinet Economic Development Committee (DEV):

- 1 **noted** that on 7 April 2021, DEV agreed to a two-part tourism recovery package to support the tourism sector to recovery and re-set nationally [DEV-21-MIN-0067];
- 2 **noted** that the Tourism Industry Transformation Plan is taking a phased approach, with the first phase focusing on Better Work and the second phase focusing on the Environment [DEV-22-MIN-0292];
- 3 **noted** that representatives from across the tourism industry, unions, government, workers and Māori have partnered to prepare a draft Tourism Environment Action Plan;
- 4 **noted** that the proposed Tirohanga Hou (new outlook and ways of viewing or thinking) identified in the draft Tourism Environment Action Plan include:
 - 4.1 tourism journeys are decarbonised;
 - 4.2 tourism champions biodiversity;
 - 4.3 visitor management is optimised for Te Taiao;
 - 4.4 tourism businesses are incentivised and enabled for sustainability and regeneration;
 - 4.5 accelerated technology uptake and innovation enables regeneration;
 - 4.6 the tourism system and its levers are optimised and resourced to support regeneration;
- 5 **agreed** to the release of the *Tourism Environment Draft Action Plan* (the draft Action Plan), attached to the paper under DEV-23-SUB-0112, for public consultation;
- 6 **authorised** the Minister of Tourism to make minor or technical changes to the draft Action Plan prior to the consultation;
- 7 **noted** that feedback from the consultation will be reflected in a final Tourism Environment Action Plan;

8 **noted** that implementation of the final Action Plan will require funding and policy support from government, as well as active and ongoing commitment from wider stakeholders, and that publication of the final Action Plan will require Cabinet approval.
